Number _____ 233-88

To change the name of part of Winston Churchill Boulevard

WHEREAS Paragraph 105 of Section 210 of the <u>Municipal Act</u> permits the councils of local municipalities to pass by-laws to change the names of public highways;

AND WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to change the name of part of Winston Churchill Boulevard, being the road allowance between the former Township of Chinguacousy and Esquesing;

AND WHEREAS notice of the intention to pass this by-law was published once a week for four consecutive weeks in the Brampton Times, a newspaper having general circulation in the City of Brampton, and in the Georgetown Herald, a newspaper having general circulation in the Town of Halton Hills;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 2 -

1. The name of the part of "Winston Churchill Boulevard" comprised of the lands described in Schedule A to this by-law, is hereby changed to "Old Pine Crest Road".

2. The affidavit of Leonard J. Mikulich attached as Schedule B hereto forms part of this by-law.

READ A FIRST, SECOND AND THIRD TIME, and PASSED, in open Council this 12th day of October, 1988.

SCHEDULE A to By-law 233-88

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Chinguacousy, County of Peel), being the part of the road allowance between the Township of Chinguacousy and the Township of Esquesing, more particularly described as follows:

PREMISING that the easterly limit of the road allowance between the Township of Chinguacousy and the Township of Esquesing has a bearing of North 44 degrees 11 minutes 55 seconds West and relating all bearings herein thereto;

Commencing at the southerly angle of Lot 12, Concession 6, West of Hurontario Street, in the former Township of Chinguacousy;

THENCE South 38 degrees 32 minutes 40 seconds West 66 feet to a point in the westerly limit of the said road allowance, said point being the easterly angle of Lot 12, Concession 11, in the former Township of Esquesing;

THENCE North 44 degrees 11 minutes 55 seconds West along the westerly limit of the said road allowance 1035.2 feet to a standard iron bar located at the point where the westerly limit of the said road allowance intersects the southerly limit of the By-law Road known as Adamson Street as described in Township of Esquesing By-law 372 registered April 16, 1885 in the Land Registry Office for the Registry Division of Halton as Instrument No. 4372.

THENCE North 38 degrees 32 minutes 40 seconds East 66 feet to a point in the easterly limit of the said road allowance;

THENCE South 44 degrees 11 minutes 55 seconds East 1035.2 feet along the easterly limit of the said road allowance to the point of commencement. SCHEDULE B to By-law 233-88
