## AMENDMENT NUMBER OP93-236 TO THE OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

#### 1.0 Purpose:

The purpose of this amendment is to change the land use designation of the lands located north of Regional Road #107 (Queen Street East) and east of Sun Pac Boulevard from "Business" to "Highway and Service Commercial" and to permit a dry cleaning and laundry establishment and distribution station, a community club, a recreation facility and structure and a banquet hall, in addition to the uses permitted under the "Highway and Service Commercial" designation.

#### 2.0 Location:

The lands subject to this amendment are located on the east side of the future Sun Pac Boulevard extension and north of Regional Road #107. The subject lands are located in Part of Lot 6, Concession 7, Northern Division in the City of Brampton.

#### 3.0 Amendments and Policies Relative Thereto:


- 3.1 The document known as the Official Plan of the City of Brampton Planning Area is hereby amended:
  - (1) by adding to the list of amendments pertaining to Secondary Plan Area Number 37: The Airport Road/Highway 7 Business Centre Secondary Plan as set out in Part II: Secondary Plans, Amendment Number OP93- 236.
- 3.2 The portions of the document known as the 1984 Official Plan of the City of Brampton Planning Area, which remain in force and as they relate to the Airport Road/Highway 7 Business Centre Secondary Plan (being Chapter 37 of Part IV Secondary Plans, as amended) are hereby further amended:
  - (1) by changing on Schedule SP37 (A) the land use designation of the lands shown outlined on Schedule "A" to this amendment from "Business" to "Highway and Service Commercial".

- (2) by adding after section 3.6.7, the following:
  - "3.6.8 The lands located at the north-east corner of Regional Road 107 and Sun Pac Boulevard having an area of approximately 4.4 hectares (10.8 acres) designated for Highway and Service Commercial, may be used for a dry cleaning and laundry establishment and distribution station, a community club, a recreation facility and structure and a banquet hall, in addition to the uses permitted under the Highway and Service Commercial designation."

- 1. I am the Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
- 2. By-law 233-2004 was passed by the Council of the Corporation of the City of Brampton at its meeting on the 11<sup>th</sup> day of August, 2004, to adopt Amendment Number OP93-236 to the 1993 Official Plan of the City of Brampton Planning Area.
- 3. By-law 234-2004 was passed by the Council of the Corporation of the City of Brampton at its meeting held on the 11<sup>th</sup> day of August, 2004, to amend Comprehensive Zoning By-law 56-83, as amended.
- 4. Written notice of By-law 233-2004 as required by section 17(23) and By-law 234-2004 as required by section 34(18) of the *Planning Act* was given on the 25<sup>th</sup> day of August, 2004, in the manner and in the form and to the persons and agencies prescribed by the Planning Act, R.S.O. 1990 as amended.
- 5. No notice of appeal was filed under sections 17(24) and 34(19) of the *Planning Act* on or before the final date for filing objections.
- 6. In all other respects this Official Plan Amendment has been processed in accordance with all of the Planning Act requirements including regulations for notice.
- 7. OP93-236 is deemed to have come into effect on the 15<sup>th</sup> day of September, 2004, in accordance with Section 17(27) of the *Planning Act*, R.S.O. 1990, as amended.
