The council of The Corporation of the City of Brampton ENACTS as follows:

- By-law 151-88, as amended, is hereby further amended by:
 - (1) by changing, on Sheet 43-B of Schedule A thereto, the zoning designations of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-HOLDING (R1B(1)-SECTION 282(H)), RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-HOLDING-SOLAR (R1B(1)-SECTION 282(H)(S1)), RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-HOLDING-SOLAR (R1B(1)-SECTION 282(H)(S2)); RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-HOLDING-SOLAR (R1B(1)-SECTION 282(H)(S3)), RESIDENTIAL TWO FAMILY A (2) - SECTION 283-HOLDING (R2A(2)-SECTION 283(H)), RESIDENTIAL TWO FAMILY A (2) - SECTION 283-HOLDING-SOLAR (R2A(2)-SECTION 283(H)(S1)), RESIDENTIAL TWO FAMILY A (2) - SECTION 283-HOLDING-SOLAR (R2A(2)-SECTION 283(H)(S2)) and RESIDENTIAL TWO FAMILY A (2) - SECTION 283-HOLDING-SOLAR (R2A(2)-SECTION 283(H)(S3)) to RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282 (R1B(1)-SECTION 282), RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-SOLAR (R1B(1)-SECTION 282(S1)), RESIDENTIAL SINGLE FAMILY B (1) - SECTION 282-SOLAR (R1B(1)-SECTION 282(S2)), RÉSÍDÉNTIAL SINGLE FAMILY B (1) - SECTIÓN 282-SOLAR (R1B(1)-SECTION 282(S3)), RESIDENTIAL TWO FAMILY A (2) - SECTION 283 (R2A(2)-SECTION 283), RESIDENTIAL TWO FAMILY A (2) - SECTION 283-SOLAR (R2A(2)-SECTION 283(S1)), RESIDENTIAL TWO FAMILY A (2) - SECTION 283-SOLAR (R2A(2)-SECTION 283(S2)) and

RESIDENTIAL TWO FAMILY A (2) - SECTION 283-SOLAR (R2A(2)-SECTION 283(S3)), such lands being part of Lot 10, Concession 1, East of Hurontario Street, in the geographic Township of Chinguacousy.
