Being a By-law for the granting of permits for the moving of vehicles or loads in excess of the limits prescribed under the Highway Traffic Act.

WHEREAS Section 66 of <u>The Highway Traffic Act</u> (R.S.O. 1970, Chapter 202, as amended) enables a Municipal Corporation to grant a permit for the moving of vehicles or loads on a Highway in excess of the limits set out in that Act;

NOW THEREFORE the Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. In this By-law,
 - "City" means The Corporation of the City of Brampton; and
 - (2) "Commissioner" means the Commission of Public Works or a person designated by him;
- 2. A vehicle, load, object or structure in excess of the dimensional limits set out in Section 65 or the weight limits set out in Part VII of <u>The Highway Traffic Act</u> (R.S.O. 1970, Chapter 202, as amended) is permitted on a Highway if
 - (1) A permit has been issued by the Commissioner, or
 - (2) A permit issued by The Regional Municipality of Peel, The City of Mississauga or Town of Caledon has been approved by the Commissioner.
- 3. The Commissioner may attach to any permit issued or approved by him any or all of the conditions or limitations setiout in subsection 66 (2) of <u>The Highway</u> <u>Traffic Act</u>, that are, in his opinion, necessary.
- 4. (1) An application for a permit and the permit shall be

in the form set out in Schedule "A" attached hereto and forming part of this By-law.

(2) The issuance or approval of a permit by the Commissioner shall be subject to the general provisions and regulations set out in the form.

GENERAL PROVISIONS

- 1. The appropriate Road Authority and the Police may change or cancel this permit at any time if it is deemed necessary or if requested to do so by any of the Agencies indicated on this form.
- 2. Bridge and Subway Weight and Clearance Limits shall be obeyed.
- 3. All sidewalk and curb crossings shall be protected by a minimum of 4" planking.
- 4. A minimum of \$500,000.00 Comprehensive Liability Insurance is required for the Movements of Buildings.
- 5. The Applicant may be required to file one or more bonds with this application in such an amount as, in the opinion of the appropriate Road Authority, is sufficient to cover the cost of repairing any possible damage to the highway resulting from the move.
- 6. The Applicant may be required to file a deposit by certified cheque with the appropriate Authority to cover costs incurred by the Authority to facilitate the move.
- 7. If an escort is required the Applicant will be required to file an escort fee by certified cheque with the Peel Region Police at the time of application.
- 8. The Applicant, his Heirs, Executors, Administrators or Assigns hereby agrees to indemnify and save harmless the above noted Road Authorities from any action, claim, damages or loss whatsoever arising from operations carried out under this permit.

 This permit is issued under the Authority of the following by-laws: Region of Peel By-law No. City of Mississauga By-law No. City of Brampton By-law No. Town of Caledon By-law No.

10. All authorizing signatures of the appropriate Road Authorities and the Agencies indicated as required on this permit, must be obtained before this permit is valid. THIS PERMIT IS NOT VALID UNLESS SIGNED BY THE POLICE.
