and Dusk Drive)


The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**


1. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 78 on Plan 43M-1882 is hereby established as part of the public highway system to be part of Lloyd Sanderson Drive;
2. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 454 on Plan 43M-1883 is hereby established as part of the public highway system to be part of Kimborough Hollow;
3. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 455 on Plan 43M-1883 is hereby established as part of the public highway system to be part of Timbercove Road;
4. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 152 on Plan 43M-1885 is hereby established as part of the public highway system to be part of Berkwood Hollow Court;
5. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 48 on Plan 43M-1888 is hereby established as part of the public highway system to be part of Berkwood Hollow Court;
6. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 49 on Plan 43M-1888 is hereby established as part of the public highway system to be part of Templar Street;
7. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 50 on Plan 43M-1888 is hereby established as part of the public highway system to be part of Vernosa Drive;

8. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 51 on Plan 43M-1888 is hereby established as part of the public highway system to be part of Ashcreek Drive;
9. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 205 on Plan 43M-1896 is hereby established as part of the public highway system to be part of Dusk Drive; and,
10. The lands acquired by The Corporation of the City of Brampton being described as 0.30m Reserve Block 201 on Plan 43M-1896 is hereby established as part of the public highway system to be part of Kimborough Hollow;
