## **BY-LAW**

Number 238 - 2007

To amend Zoning By-law 2004, as amended

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. Zoning By-law 2004, as amended, is hereby further amended:
  - (1) by deleting the words "in 13.4.2(a)" in subsections 13.4.2(f) and 13.4.2(j)
  - (2) by deleting subsections 13.4.2(j)(4) and 13.5.2(j)(4) and replacing it with the following:
    - the maximum interior garage width, of an attached garage, shall be 0.6 metres wider than the maximum permitted cumulative garage door width.
    - 5) on lots greater than 14 metres wide, the maximum interior garage width shall not exceed 50% of the dwelling unit width."
  - (3) by deleting the words "in 13.5.2(a)" in subsections 13.5.2(f) and 13.5.2(j)
  - (4) by deleting the words "in 15.7.2(a)" in subsection 15.7.2(k)
  - (5) by deleting the words "in 15.8.2(a)" in subsection 15.8.2(k)
  - (6) by deleting the words "in 16.9.2(a)" in subsection 16.9.2(k)
  - (7) by deleting the words "in 16.10.2(a)" in subsection 16.10.2(k)


