

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number _____ 241-89

To amend By-law 151-88 (part of (Lot 12, Concession 1, E.H.S., in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

(1) by changing, on Sheet 25-G of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to COMMERCIAL ONE-SECTION 471 (C1-SECTION 471), such lands being part of Lot 12, Concession 1, East of Hurontario Street in the geographic Township of Chinguacousy, now in the City of Brampton.

2. by adding thereto the following section:

"471 The lands designated C1-SECTION 471 on Sheet 25-G of Schedule A to this by-law:

471.1 shall only be used for:

- (1) the purposes permitted in a Cl zone by section 31.1.1.
- 471.2 shall be subject to the following requirements and restrictions:
 - (1) the minimum interior side yard width shall be 7.6 metres;
 - (2) the minimum rear yard depth shall be3.0 metres;

(3) the maximum building height shall not exceed 1 storey;

- 2 -

- (4) all garbage and refuse containers shall be enclosed within the main building;
- (5) garbage and refuse containers for a restaurant shall be located within a climate-controlled area within the building;
- 471.3 shall be subject to the requirements and restrictions relating to the C1 zone and all the general provisions of this by-law which are not in conflict with the ones set out in section 471.2."


