
To accept and assume lands as part

of Brampton.


WHEREAS it is deemed expedient to accept and assume lands

highway adjacent thereto.

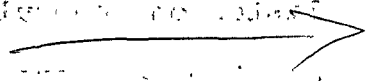

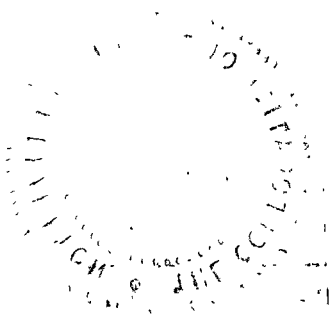
