

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number _____ 244-93

To amend By-law 151-88 as amended (part of Lot 13, Concession 1, W.H.S., in the Geographic Township of Chinguacousy)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

- by changing on Sheet 24F of Schedule "A" thereto, the zoning designation of the lands shown outlined on Schedule "A" to this by-law from INDUSTRIAL TWO (M2) to INDUSTRIAL TWO SECTION 680 (M2 SECTION 680), such lands being part of Lot 13, Concession 1, West of Hurontario Street, in the geographic Township of Chinguacousy.
- (2) by adding thereto the following section:

"680 The lands designated M2 - Section 680 on Sheet 24F of Schedule A to this by-law:

Permitted Purposes

- 680.1 shall only be used for the following purposes:
 - (1) the purposes permitted in the M2 zone; and
 - (2) a day nursery.

Requirements and Restrictions

- 680.2 shall be subject to the following requirements and restrictions
 - (1) the requirements and restrictionscontained in the M2 zone.

680.3 shall also be subject to the the general provisions of this by-law, which are not in conflict with the ones set out in section 680.1.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this ^{27th} day of **October**, 1993.


