Number 248-86

To amend By-law 139-84 (part of Lot 15, Concession 1, E.H.S., in the geographic Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby amended:

- (1) by changing, on Sheet 7 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from OPEN SPACE (P) (OS(P)) and RESIDENTIAL APARTMENT A (P) - SECTION 576 (R4A(P) - SECTION 576) to RESIDENTIAL APARTMENT A (P) - SECTION 576 (R4A(P) - SECTION 576) and OPEN SPACE (P) (OS(P)).

READ a FIRST, SECOND and THIRD TIME, and PASSED in OPEN COUNCIL


