BY-LAW

Number _____ 250-88

To amend By-law 139-84 (part of Lot 15, Concession 1, W.H.S., in the geographic Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 139-84, as amended, is hereby further amended:
 - (1) by changing, on Sheet 6 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL A to RESIDENTIAL SINGLE FAMILY B SECTION 673 ZONE (R1B SECTION 673), RESIDENTIAL SINGLE FAMILY C ZONE (R1C), RESIDENTIAL SINGLE FAMILY D ZONE (R1D), RESIDENTIAL STREET TOWNHOUSE ZONE (R3B), RESIDENTIAL STREET TOWNHOUSE HOLDING ZONE (R3B(H)) and FLOODPLAIN (F).
 - (2) by adding thereto the following section:
 - "673. The lands designated RlB SECTION 673 on Sheet 6 of Schedule A to this by-law:
 - 673.1 shall only be used for the purposes permitted by section 12.2.1.
 - 673.2 shall be subject to the following requirements and restrictions:
 - (1) any accessory building or structure, including a swimming pool, shall not be located any closer than 3.0 metres to the boundary of a FLOODPLAIN
 (F) zone.
 - 673.3 shall also be subject to the requirements and restrictions relating to the RIB Zone and all of the general provisions of this by-law which are not in conflict with the ones set out in section 673.2."


