To accept and assume as public highways certain streets and lands shown on Registered Plan M-76


WHEREAS it is deemed expedient to accept and assume certain streets and lands shown on Registered Plan M-76 as public highways;

NOW THEREFORE The Council of The Corporation of the City of Brampton hereby ENACTS AS FOLLOWS:

1. The lands dedicated as public highways and described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 10th day of October, 1984.
