BY-LAW

Number 251-2001

To amend By-law 151-88, as amended

The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 151-88, as amended, is hereby further amended:
 - (1) by changing on Sheet 21A of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to INSTITUTIONAL TWO SECTION 1113 (I2 SECTION 1113);
 - (2) by adding thereto, the following section:
 - "1113 The lands designated I2 SECTION 1113 on Sheet 21A of Schedule A to this by-law:
 - shall only be used for the following purposes:
 - (1) a fire station;
 - (2) a park, playground or recreation facility operated by a public authority; and,
 - purposes accessory to the other permitted purposes.
 - shall be subject to the requirements and restrictions relating to the "Institutional Two (I2)" zone and all the general provisions of this by-law."

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL, this **15th** day of **AUGUST** 2001.




