To amend By-law 861, as amended, of the former Township of Chinguacousy, now in the City of Brampton.

The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 861, as specifically amended by By-law 229-80 and 11-81, is hereby amended:
 - (1) by adding to section 2 (DEFINITIONS) the following as subsection 43a:
 - "43a PARKING SPACE, TANDEM shall mean a parking space which has access to a driveway or aisle used for vehicular traffic only over another parking space."
 - (2) by adding thereto to section 16J the following as subsections (3) (n) & (o):
 - "(n) Parking requirements:

MOTOR VEHICLE REPAIR SHOP 1 parking space for OR MOTOR VEHICLE BODY SHOP each 18 square metres

l parking space for each 18 square metres of gross commercial floor area or portion thereof of which 50 per cent of the required spaces may be tandem parking spaces.

MOTOR VEHICLE SERVICE STATION

1 parking space for each 23 square metres of gross commercial floor area or portion thereof.

MOTOR VEHICLE WASHING 5 parking spaces **ESTABLISHMENT**

- (o) For each Motor Vehicle Washing Establishment there shall be provided a driveway of at least 65.0 metres in length and 3.0 metres in width providing direct access from the street to the entrance of the Motor Vehicle Washing Establishment."
- (3) by adding thereto to section 16K the following as subsections (2) (n) & (o):
 - "(n) Parking requirements:

MOTOR VEHICLE SERVICE STATION

1 parking space for each 23 square metres of gross commercial floor area or portion thereof.

MOTOR VEHICLE WASHING 5 parking spaces. **ESTABLISHMENT**

(o) For each Motor Vehicle Washing Establishment there shall be provided a driveway of at least 65.0 metres in length and 3.0 metres in width providing direct access from the street to the entrance of the Motor Vehicle Washing Establishment."
