# BY-LAW

**Number** 256-2004

To Appoint Municipal By-law Enforcement Officers and to Repeal By-law 150-2004

WHEREAS section 8 of the Municipal Act (S.O. 2001, c. M.25, as amended) gives powers and privileges of a natural person for exercising its authority under the Municipal Act or any other Act;

AND WHEREAS section 227 of the Municipal Act, (S.O. 2001, c. M.25, as amended) establishes the role of employees to carry out duties required or assigned under the Municipal Act or any other Act;


AND WHEREAS section 15 of the Police Services Act (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The persons named in Schedule I attached hereto are hereby appointed as Municipal Law Enforcement Officers for the City of Brampton.
2. By-law 150-2004 is hereby repealed.
