# BY-LAW

**Number** 261-85

To amend By-law 200-82 (part of Lot 6, Concession 2, W.H.S., geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:

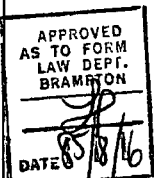
1. By-law 200-82, as amended, is hereby further amended:
  - (1) by changing the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL HOLDING (RH) to RESIDENTIAL SINGLE-FAMILY (R1B), such lands being part of Lot 6, Concession 2, West of Hurontario Street, in the geographic Township of Chinguacousy;
  - (2) by deleting therefrom Sheet 1 of Schedule A thereto, and substituting therefor Schedule B to this by-law.

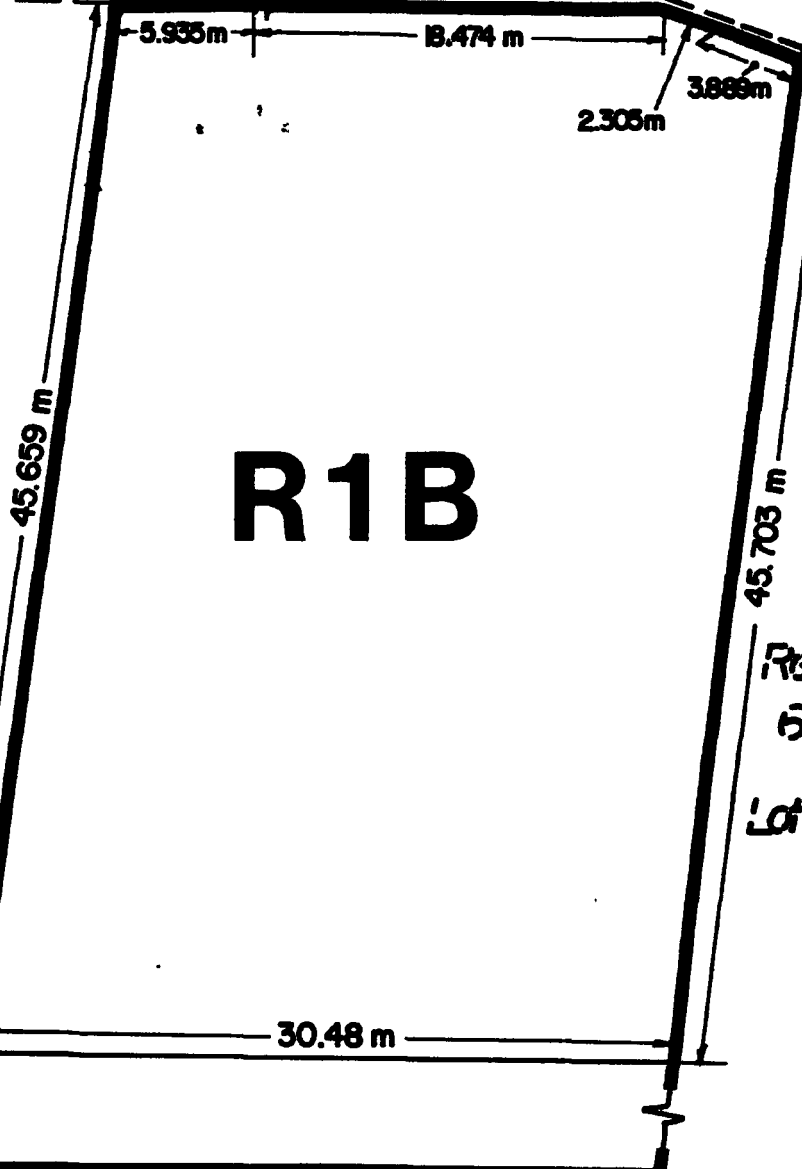

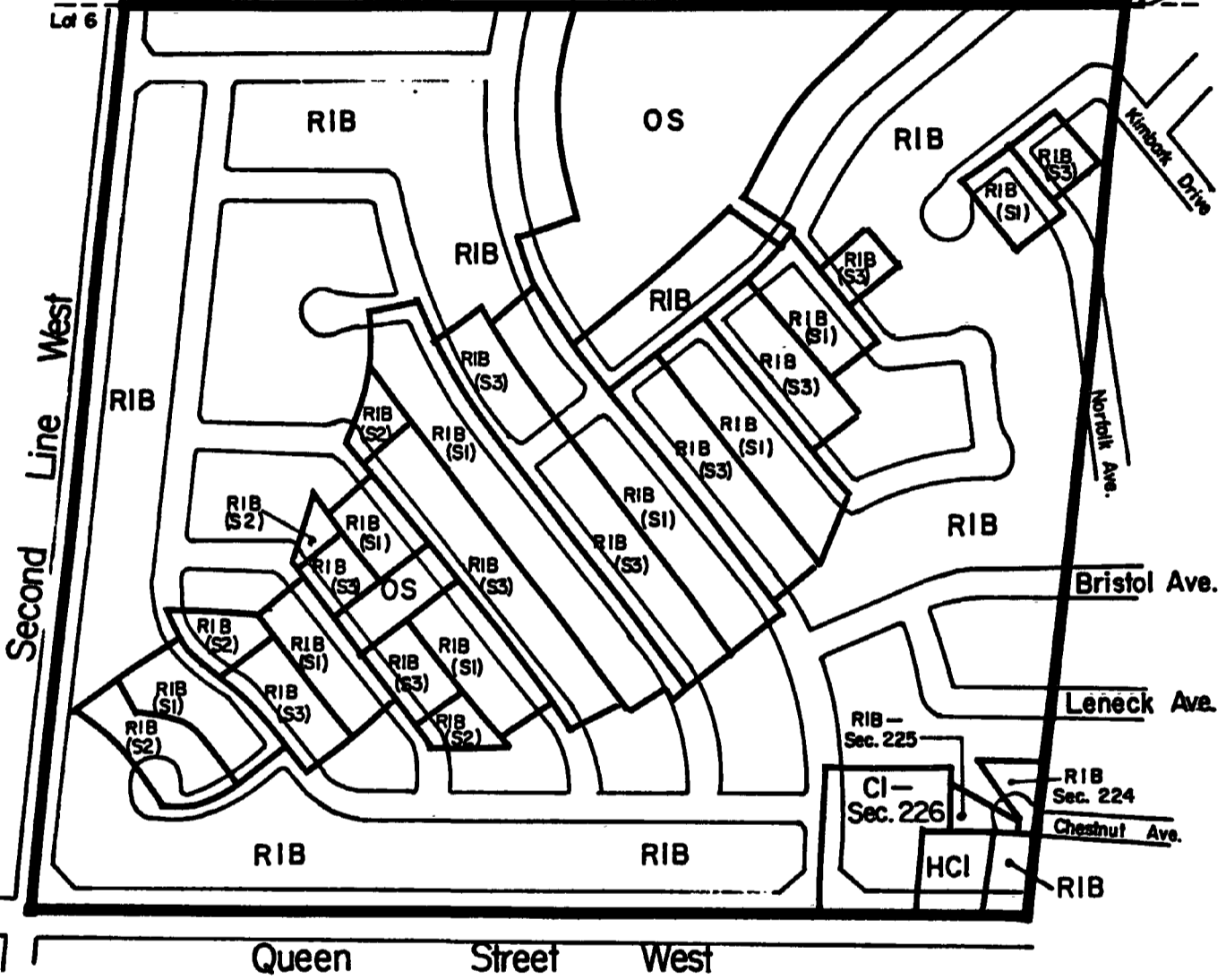

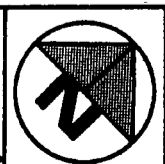
Lot 7 North Westerly Corner of the Westerly Half of Lot 6


