



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 262-89

To amend By-law 56-83 (part of Lot 15, Concession 9, N.D., in the geographic Township of Toronto Gore)

The council of The Corporation of the City of Brampton
ENACTS as follows:

1. By-law 56-83, as amended, is hereby further amended:
 - (1) by changing, on Sheet 9 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL ESTATE HOLDING (REH) and FLOODPLAIN (F) to RESIDENTIAL ESTATE TWO (RE2), RESIDENTIAL ESTATE TWO-SECTION 582 (RE2-SECTION 582) and FLOODPLAIN (F), such lands being part of Lot 15, Concession 9, Northern Division, in the geographic Township of Toronto Gore.
 - (2) by adding thereto the following section:

"582 The lands designated RE2-SECTION 582 on Sheet 9 of Schedule A to this by-law:

582.1 shall only be used for the purposes permitted by section 11.2.1

582.2 shall be subject to the following requirements and restrictions:

 - (a) the minimum lot width shall be 25.0 metres

582.3 shall also be subject to the requirements and restrictions relating to the RE2 zone, and all the general provisions of this by-law, which are not in conflict with those set out in section 582.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN
COUNCIL, this 11th day of October 1989.

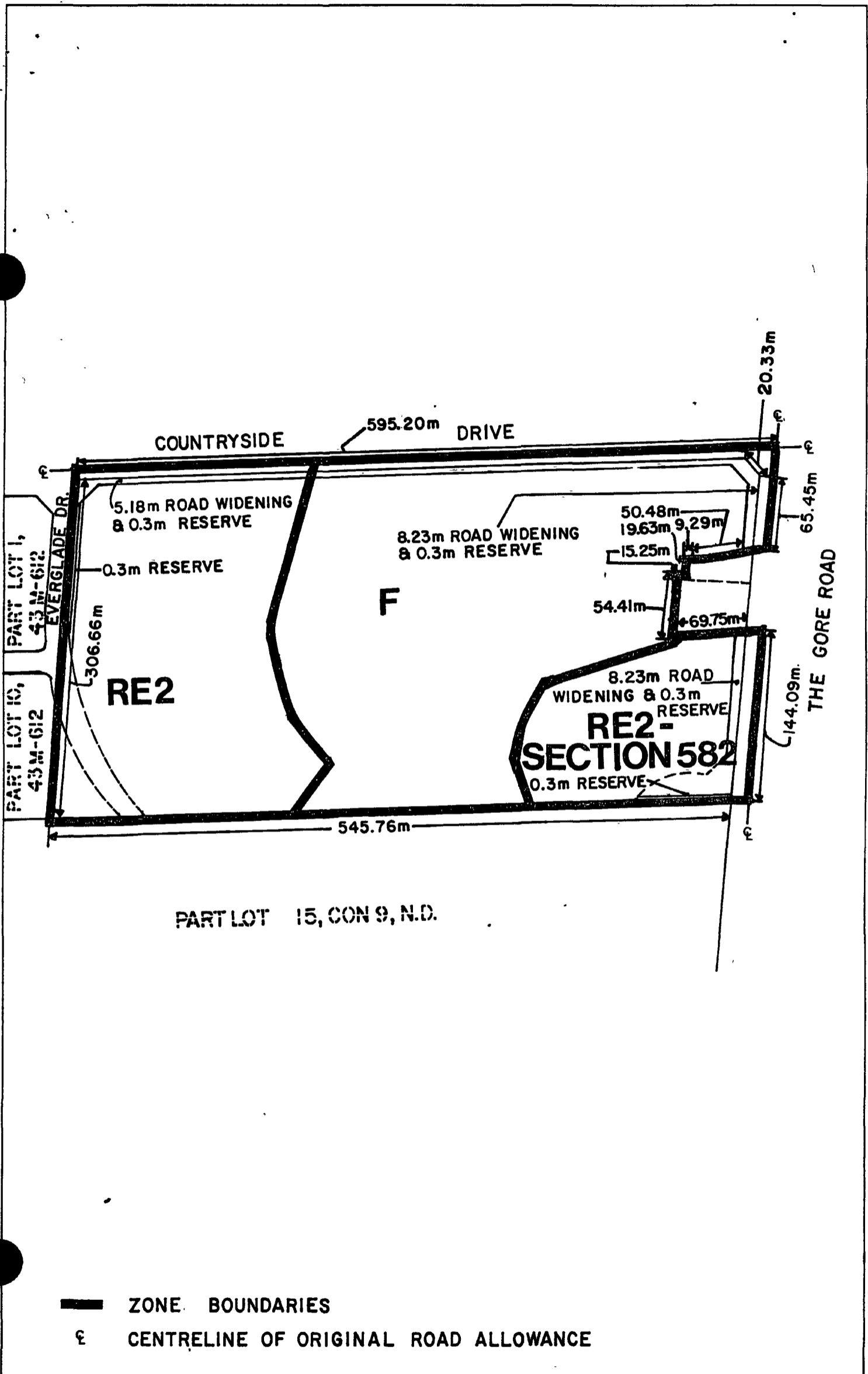
