# BY-LAW



To amend Interim Control By-Law 35-2013, An Interim Control By-Law applicable to Part of the Area Subject to By-Law 270-2004, as amended, and known municipally as 26 Morpeth Road.

The Council of the Corporation of the City of Brampton ENACTS as follows:


1. By-Law 35-2013, as amended, is hereby amended as follows:
  - 1.1 Section 1 is amended by adding after the words "Except as provided for in Section 1.1, Section 1.2, Section 1.3, Section 1.4, Section 1.5, Section 1.6, Section 1.7, Section 1.8, Section 1.9, Section 1.10, Section 1.11, Section 1.12, Section 1.13, Section 1.14, Section 1.15 and Section 1.16, the following:  
 "Section 1.18"
  - 1.2 The following is added as Section 1.18:  
 "1.18 On lands described as Concession 8 WHS, Part of Lot 13 and referenced as the "Lands Subject to Specific Exemption From Interim Control By-Law 35-2013, as amended by By-Law 264-2013 " and as shown on Schedule A to this by-law as 26 Morpeth Road, there shall be permitted an addition to the principal dwelling resulting in a total gross floor area of the principal dwelling not exceeding 205 square meters."
2. By-Law 35-2013 is hereby further amended by adding thereto, as Schedule A to this by-law.
