# Number 264-2014

A By-law to amend the Schedules of Traffic By-law 93-93, relating to FIRE ROUTES (Schedule XXII), THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), NO STOPPING (Schedule XV), SCHOOL BUS LOADING ZONE (Schedule VIII) and U-TURNS (Schedule II)

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXII:
