# BY-LAW

Number 264-2014

**A By-law to amend the Schedules of Traffic By-law 93-93, relating to FIRE ROUTES (Schedule XXII), THROUGH HIGHWAYS (Schedule III), STOP SIGNS (Schedule IV), NO STOPPING (Schedule XV), SCHOOL BUS LOADING ZONE (Schedule VIII) and U-TURNS (Schedule II)**

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XXII:

### FIRE ROUTES

5. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XV:

Montjoy Crescent	East	Maitland Street (easterly intersection) and a point 130 meters south of Maitland Street (easterly intersection)	Monday to Friday 8:00 a.m. to 5:00 p.m.
Fernforest Drive	East	A point 30 meters north of Father Tobin Road and Father Tobin Road	Monday to Friday 8:00 a.m. to 5:00 p.m.

6. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule VIII:

**SCHOOL BUS LOADING ZONE**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 SCHOOL OR INSTITUTION
Wardsville Drive	South	Gosling Street and a point 60 metres east of Gosling Street	Eldorado Public School


7. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule II:


**U-TURNS**

Maitland Street	A point 15 meters west of Montjoy Crescent (easterly intersection) and a point 81 meters east of Montjoy Crescent (easterly intersection)
