# BY-LAW

Number 265-85

To amend By-law 139-84 (the  
Mississauga comprehensive  
zoning by-law)

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended:

(1) by deleting therefrom sections 46.1.2(b)(5), 46.1.2(c)(5), 46.2.2(b)(5) and 46.2.2 (c)(5), and substituting therefor the following:

"(5) Maximum height of buildings other than those used for agricultural uses or purposes accessory thereto 10.5 metres"

(2) by deleting therefrom Sheets 1, 2, 3, 4, 5, 9, 10, 11 and 12 of Schedule A thereto, and substituting therefor Schedules A, B, C, D, E, F, G, H and I to this by-law.

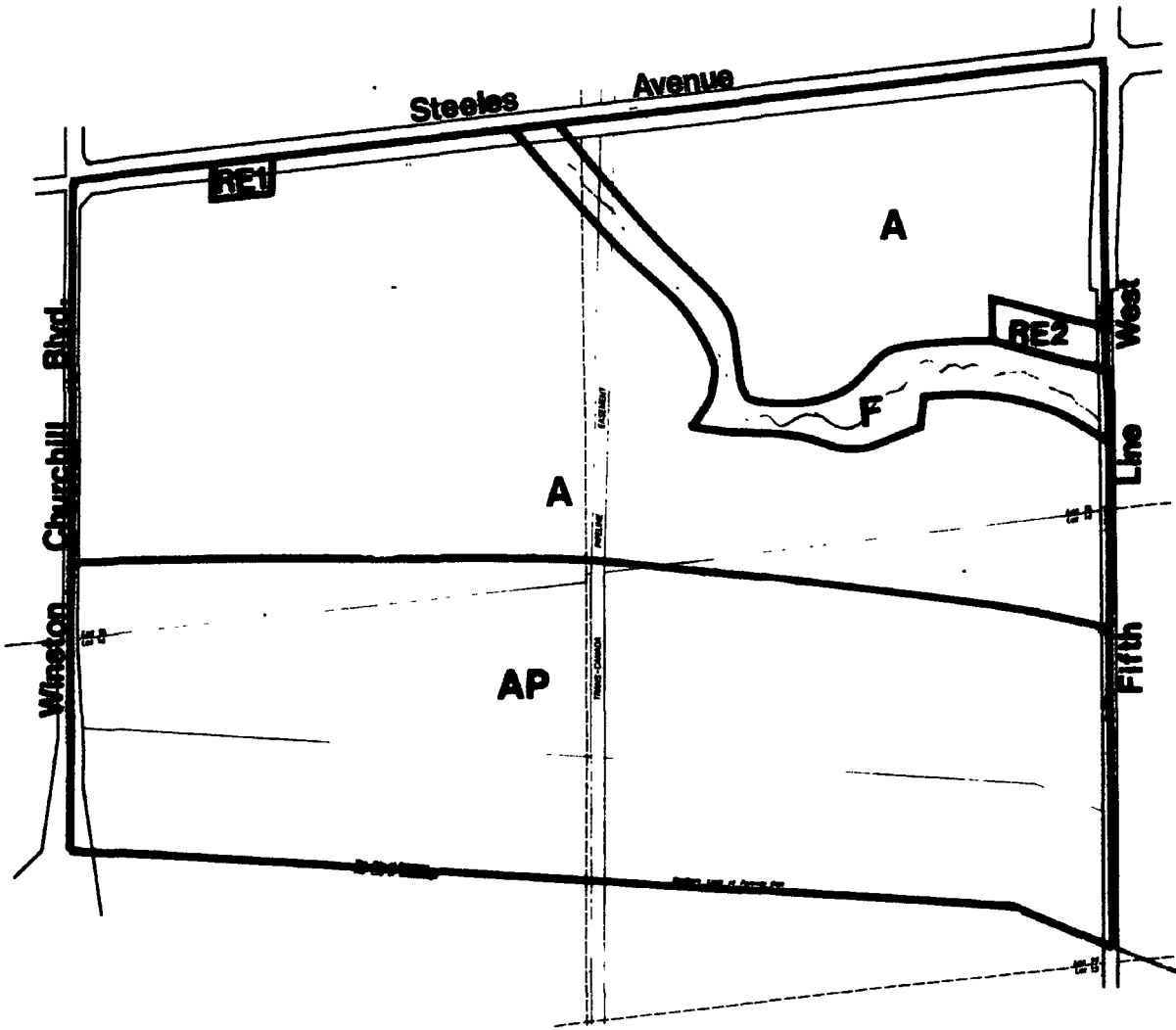

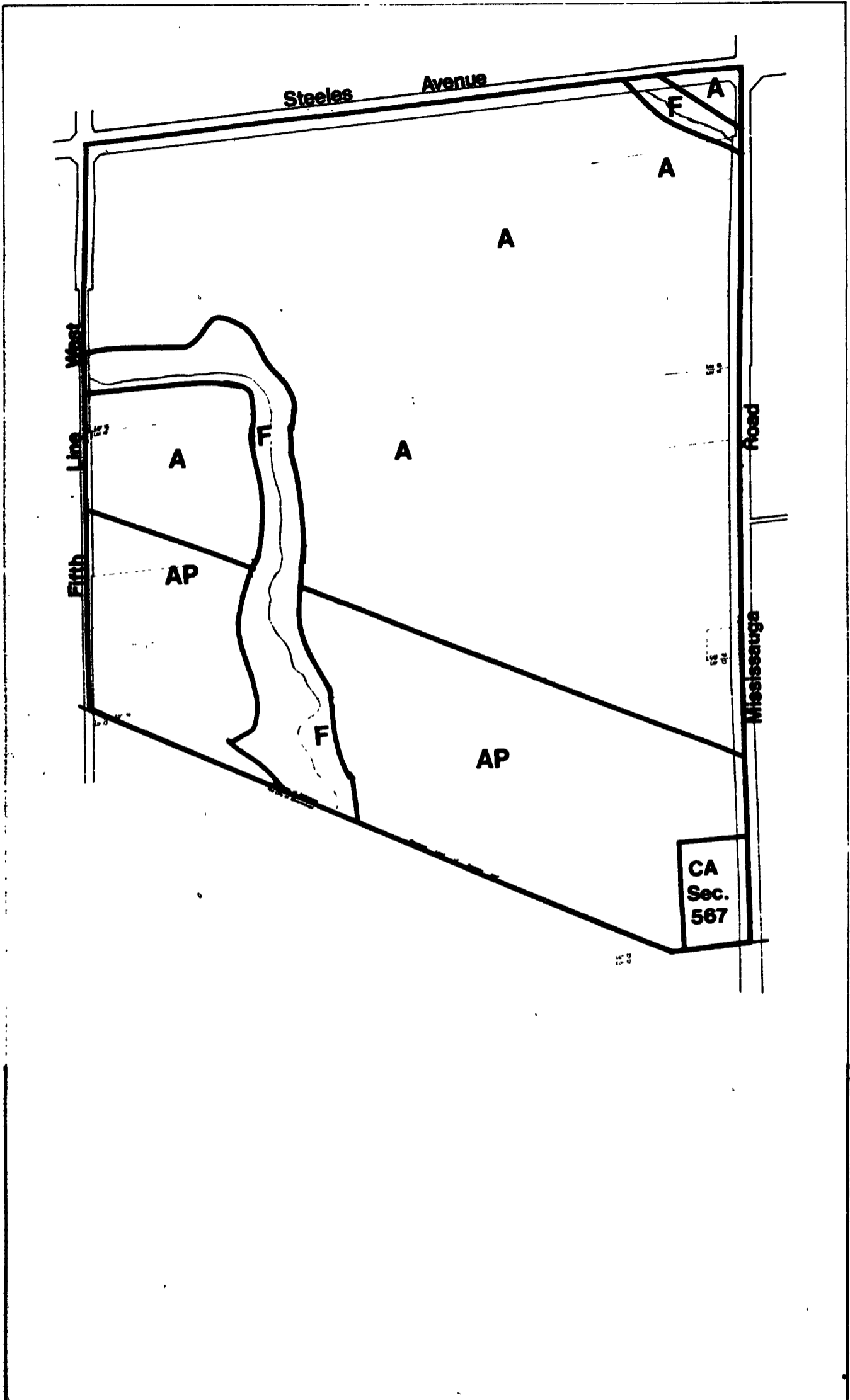

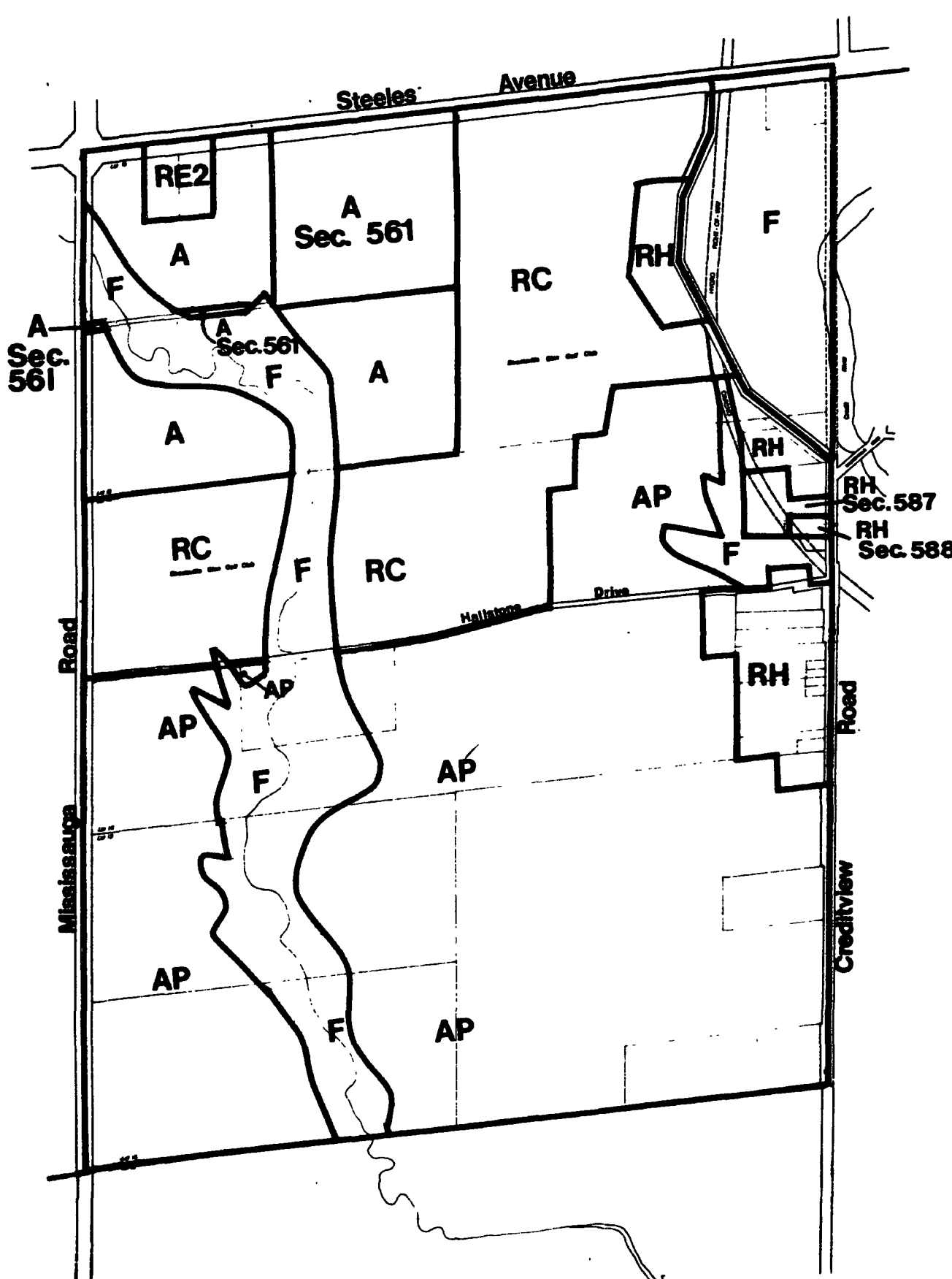

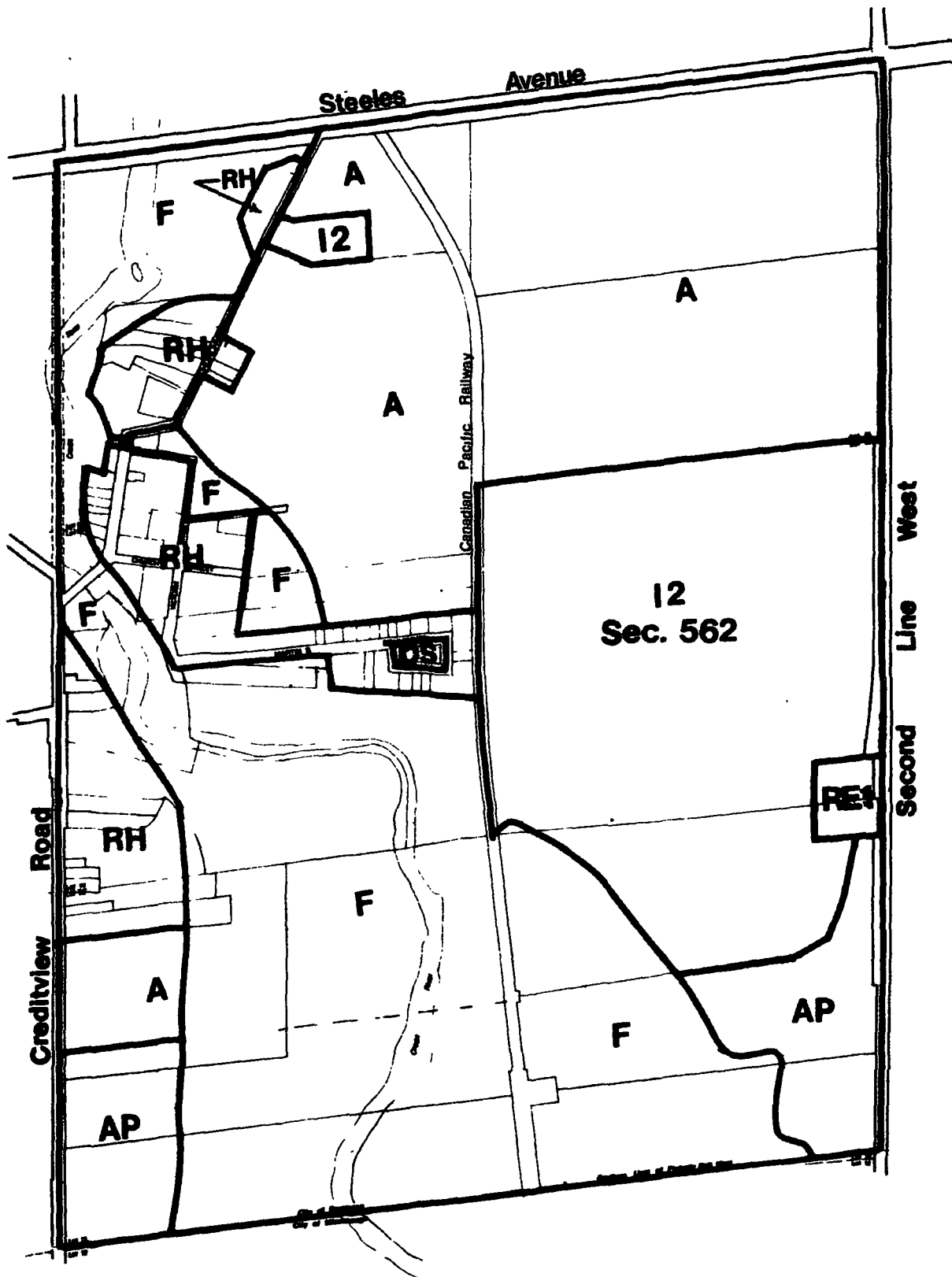

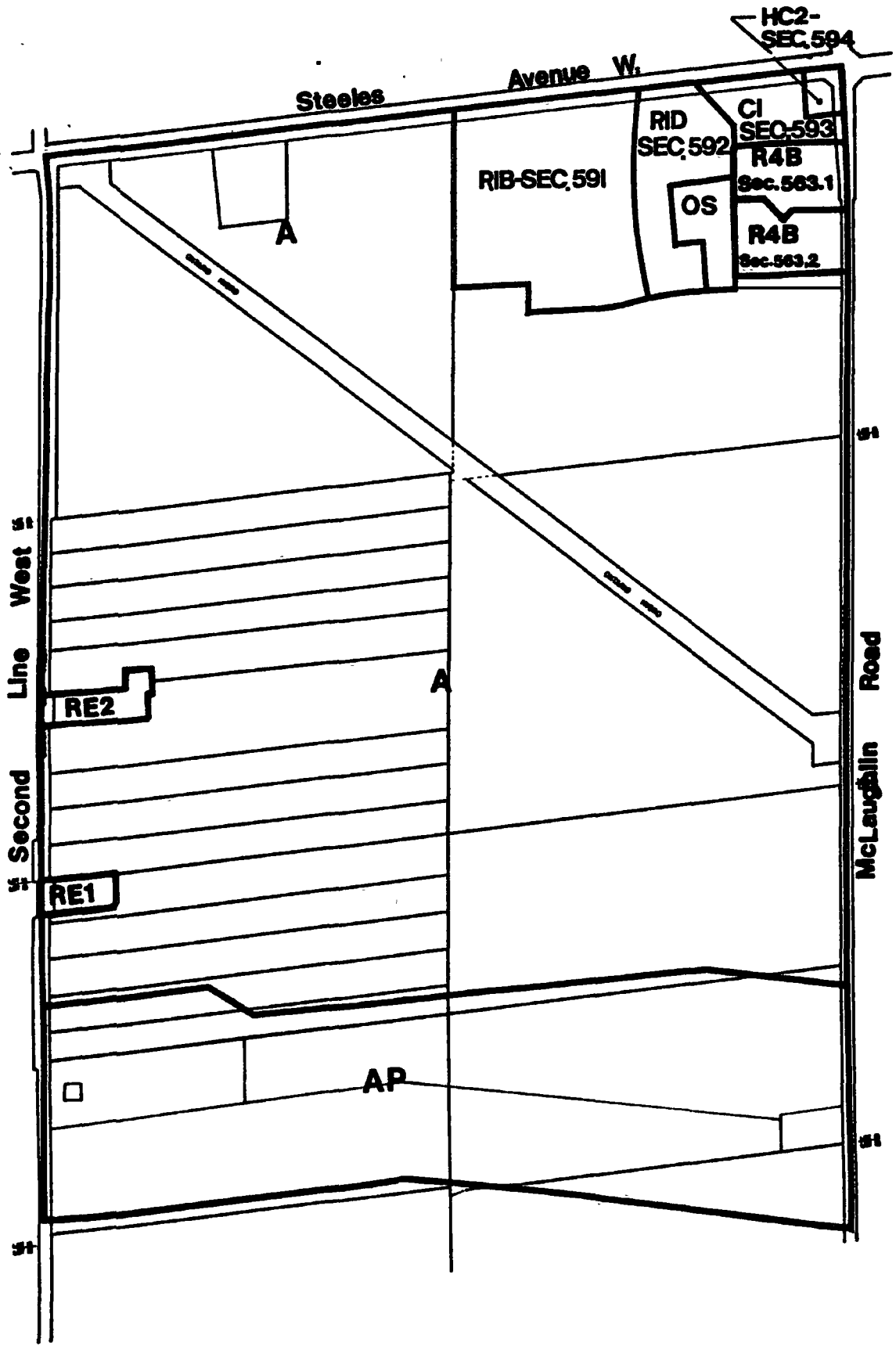

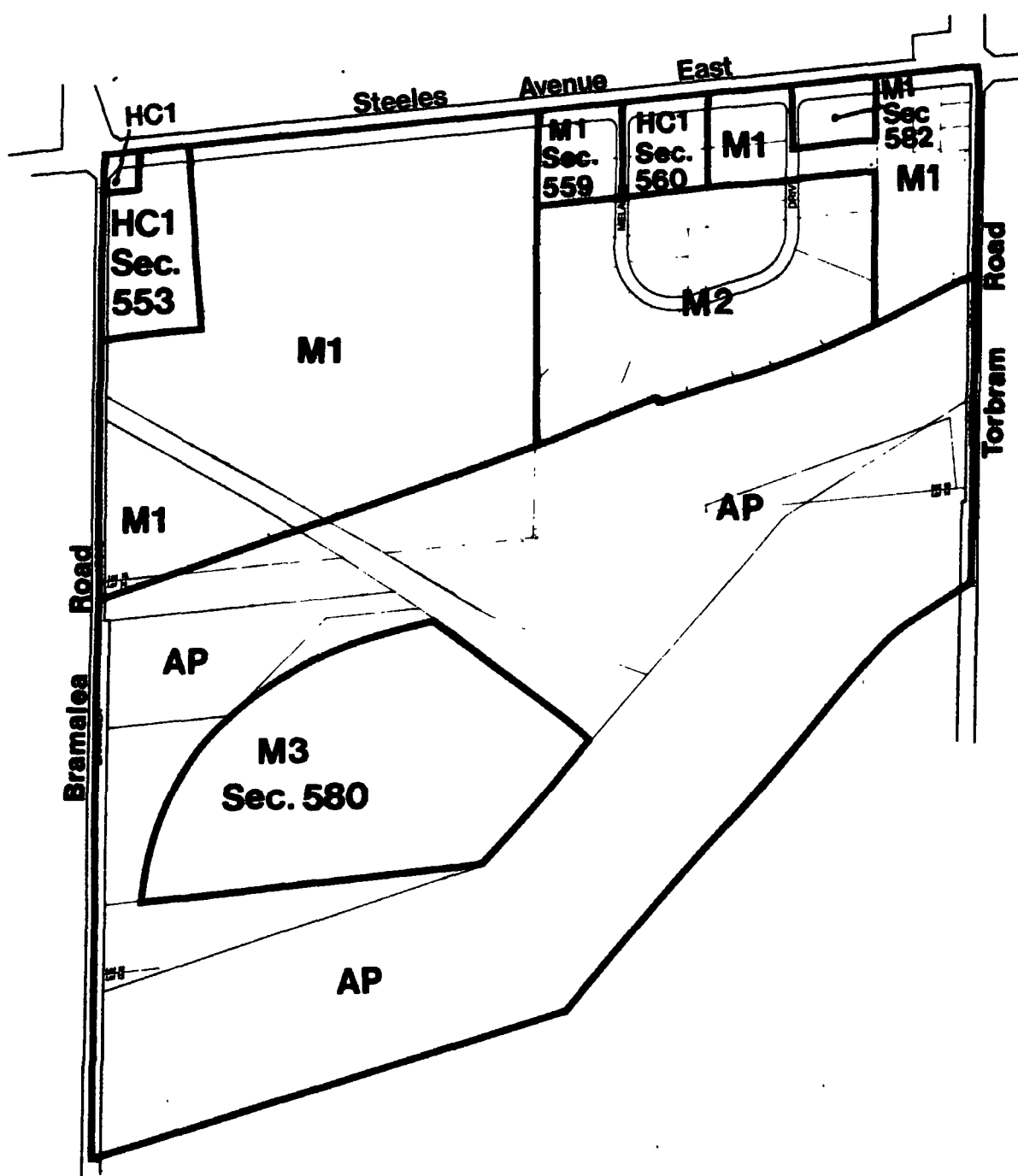

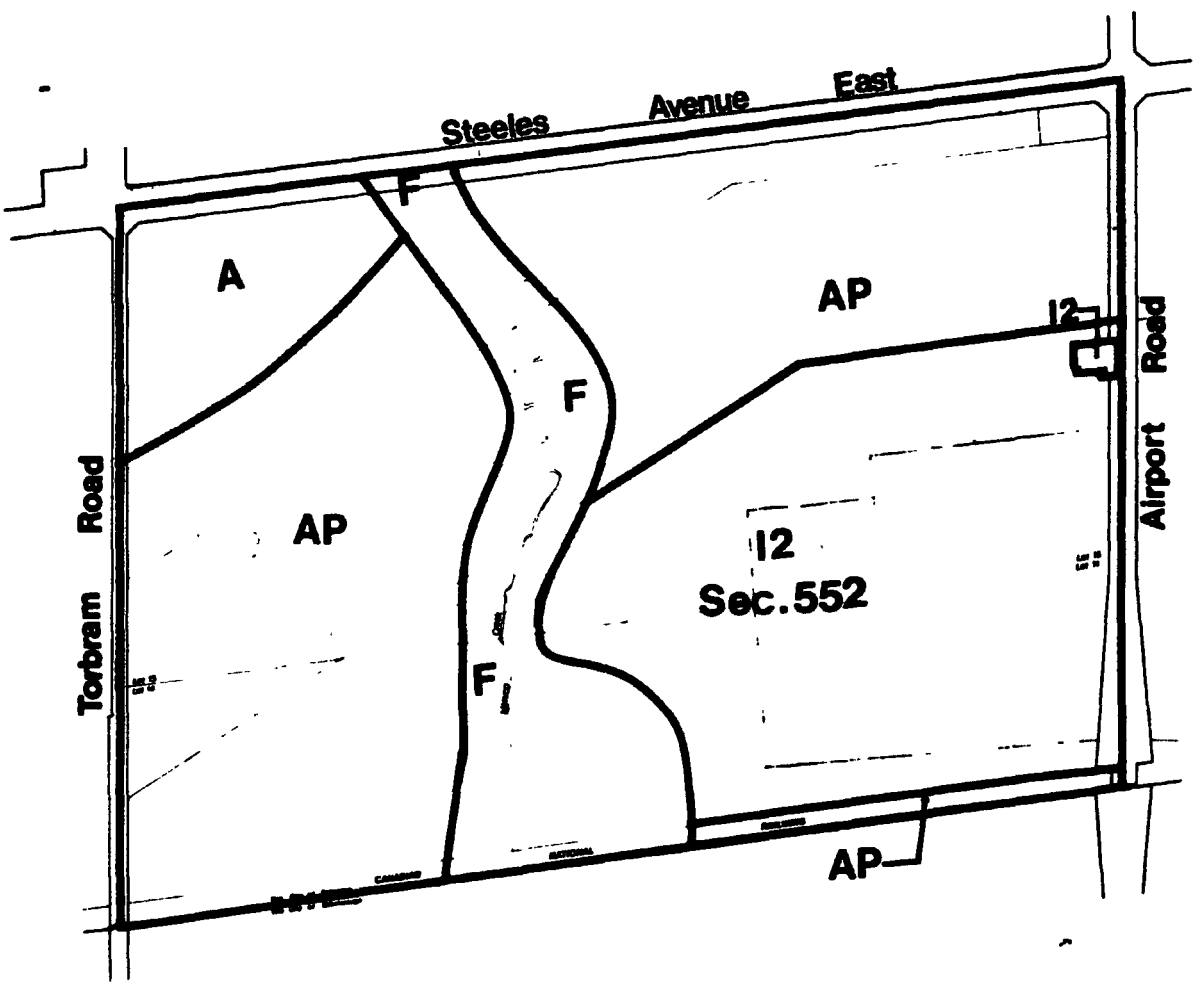


DECLARATION
