A By-law to Amend By-law 243-2009 Appointing Officers to Enforce Parking on Private Property

WHEREAS section 9 of the *Municipal Act, 2001* (S.O. 2001, c. M.25, as amended) gives powers and privileges of a natural person for exercising its authority under the *Municipal Act, 2001* or any other Act;

AND WHEREAS section 227 of the *Municipal Act, 2001,* (S.O. 2001, c. M.25, as amended) establishes the role of employees to carry out duties required or assigned under the *Municipal Act, 2001* or any other Act;

AND WHEREAS section 15 of the Police Services Act (R.S.O. 1990, c.P.15) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

THE COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON ENACTS AS FOLLOWS:

1.

By-law 243-2009 is hereby amended as follows:

Replace Schedule A to By-law 243-2009 with the attached Schedule I to this by-law.

2. A municipal law enforcement officer appointed by this By-law may enter on land at any reasonable time for the purpose of carrying out an inspection to determine whether or not the following are being complied with:

- (a) a by-law of The Corporation of the City of Brampton passed under the *Municipal Act, 2001*, as amended;
- (b) a direction or order of The Corporation of the City of Brampton made under the *Municipal Act, 2001*, as amended, or made under a by-law;
- (c) a condition of a license issued under a by-law; or
- (d) an order made under section 431 of the *Municipal Act, 2001*, as amended.
