BY-LAW NUMBER 267-75

A By-law to amend By-law Number 37-74 as amended respecting parking meters on the streets within The Corporation of the City of Brampton.

WHEREAS the Council of The Corporation of the City of Brampton deems it expedient and advisable to further amend By-law Number 37-74, being a By-law respecting parking meters on streets within The Corporation of the City of Brampton.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- 1) That Schedule "A" to By-law Number 37-74, as amended, be further amended by the deletion therefrom of the following under the appropriate columns thereof.


<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>FEEES AND TIME LIMITS</u>	<u>MAXIMUM PARKING PERIOD</u>
Queen St. E.	South	A point 170' east of the centre line of Main St. S. and a point 50' west of the centre line of Chapel Street	5¢ for 15 min.; 10¢ for 30 min.	60 min.
Queen St. W.	North	A point 76' west of the centre line of Main St. N. and a point 122' east of the centre line of George Street North	5¢ for 15 min.; 10¢ for 30 min.	60 min.
Main St. N.	East	A point 120' north of the centre line of Queen St. E. to a point 52' south of the centre line of California St.	5¢ for 15 min.; 10¢ for 30 min.	60 min.


- 2) That Schedule "A" to By-law Number 37-74, as amended, be further amended by the addition thereto of the following under the appropriate columns thereof.

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>FEEES AND TIME LIMITS</u>	<u>MAXIMUM PARKING PERIOD</u>
Queen St. E.	South	A point 193' east of the centre line of Main St. S. and a point 50' west of the centre line of Chapel Street	5¢ for 15 min.; 10¢ for 30 min.	60 min.
Queen St. W.	North	A point <del>122</del> <sup>143</sup> west of the centre line of Main St. N and a point 122' east of the centre line of George St. N.	5¢ for 15 min.; 10¢ for 30 min.	60 min.

<u>ROAD</u>	<u>SIDE</u>	<u>BETWEEN</u>	<u>FEEES AND TIME LIMITS</u>	<u>MAXIMUM PARKING PERIOD</u>
Main St. N. East		A point 142' north of the centre line of Queen St. E. and a point 52' south of the centre line of California St.	5¢ for 15 min.; 10¢ for 30 min.	60 min.
