The council of The Corporation of the City of Brampton ENACTS as follows:

- By-law 139-84, as amended, is hereby further amended:
 - (1) by renumbering subsections 10.9.1(a) (1), (2) and (3) to subsections 10.9.1(a) (3), (4) and (5), respectively; and,
 - (2) by adding to Section 10.9.1(a) thereof, the following subsections:
 - "(1) a parking space shall be a rectangular area having a minimum, unobstructed width of 2.75 metres and a minimum, unobstructed length of 6.0 metres;
 - (2) a parallel parking space shall be a rectangular area having a minimum, unobstructed width of 2.75 metres and a minimum, unobstructed length of 6.5 metres, the long side of which is parallel to an aisle;"
 - (3) by deleting renumbered Section 10.9.1(a)(5) thereof and substituting therefor the following new subsection:
 - "(5) the minimum width of a driveway shall be 3 metres and shall not exceed 50 percent of the lot width unless such maximum driveway width would conflict with the minimum landscaped open space yard requirement in the applicable zone, in which case, the minimum landscaped open space requirement shall prevail."
