Lot 2, Concession 7, Northern Division in the geographic Township of Toronto Gore

The council of The Corporation of the City of Brampton **ENACTS** as follows:

- By-law 56-83, as amended, is hereby further amended: 1.
  - (1) by changing, on Sheet 18 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from INDUSTRIAL THREE-SECTION 529 (M3-SECTION 529) to INDUSTRIAL THREE-SECTION 581 (M3-SECTION 581), such lands being part of Lot 2, Concession 7, Northern Division in the geographic Township of Toronto Gore.
  - (2) by adding thereto the following section:
    - "581 The lands designated M3-SECTION 581 on Sheet 18 of Schedule A to this by-law:
      - 581.1 shall only be used for the following purposes:
        - (a) the purposes permitted by section 529.1;
        - (b) the sale and leasing of new and used trucks in connection with the industrial use;
        - (c) the outside storage of new and used trucks in connection with the industrial use;

- (d) the service and repair of new and used trucks in connection with the industrial use, and
- (e) purposes accessory to the other permitted purposes including a retail outlet operated in conjunction with an industrial use located on the site, provided that the total gross floor area of the retail outlet is not more than twenty percent (20%) of the total gross floor area of the industrial use.
- 581.2 shall be subject to the following requirements and restrictions:
  - (a) the requirements and restrictions of section 529.2, and
  - (b) the storage area will not be permitted in the front yard.
- 581.3 shall also be subject to the requirements and restrictions relating to the M3 zone, and all the general provisions of this bylaw, which are not in conflict with those set out in section 581.2."


READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 23rd day of October 1989.
