# **BY-LAW**

Number 272-2004.

To amend By-law 151-88, as amended and the Zoning By-law 2004

The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 151-88, as amended, is hereby further amended and Zoning By-law 2004, are hereby further amended:
  - (1) by changing on Schedule "A" thereto of both By-laws, the zoning designation of the lands shown outlined on Schedule "A" attached to this by-law from RESIDENTIAL SINGLE DETACHED C SECTION 1229 (R1C SECTION 1229) AND RESIDENTIAL STREET TOWNHOUSE B SECTION 1234 (R3B SECTION 1234) TO RESIDENTIAL SINGLE DETACHED C SECTION 1230 (R1C SECTION 1230), RESIDENTIAL SINGLE DETACHED C SECTION 1231 (R1C SECTION 1231) AND RESIDENTIAL SEMI DETACHED C SECTION 1233 (R2C SECTION 1233)).

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL, this day of Section 2004.




