To amend By-law 139-84 (Part of Lot 13, Concession 2, W.H.S., geographic Township of Toronto)


The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended:

- (1) by changing, on sheet 5 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY C (R1C), RESIDENTIAL SINGLE FAMILY D - SECTION 780 (R1D-SECTION 780), RESIDENTIAL STREET TOWNHOUSE (R3B), INSTITUTIONAL ONE (I1) and OPEN SPACE (OS), such lands being part of Lot 13, Concession 2, W.H.S., in the geographic Township of Toronto.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,



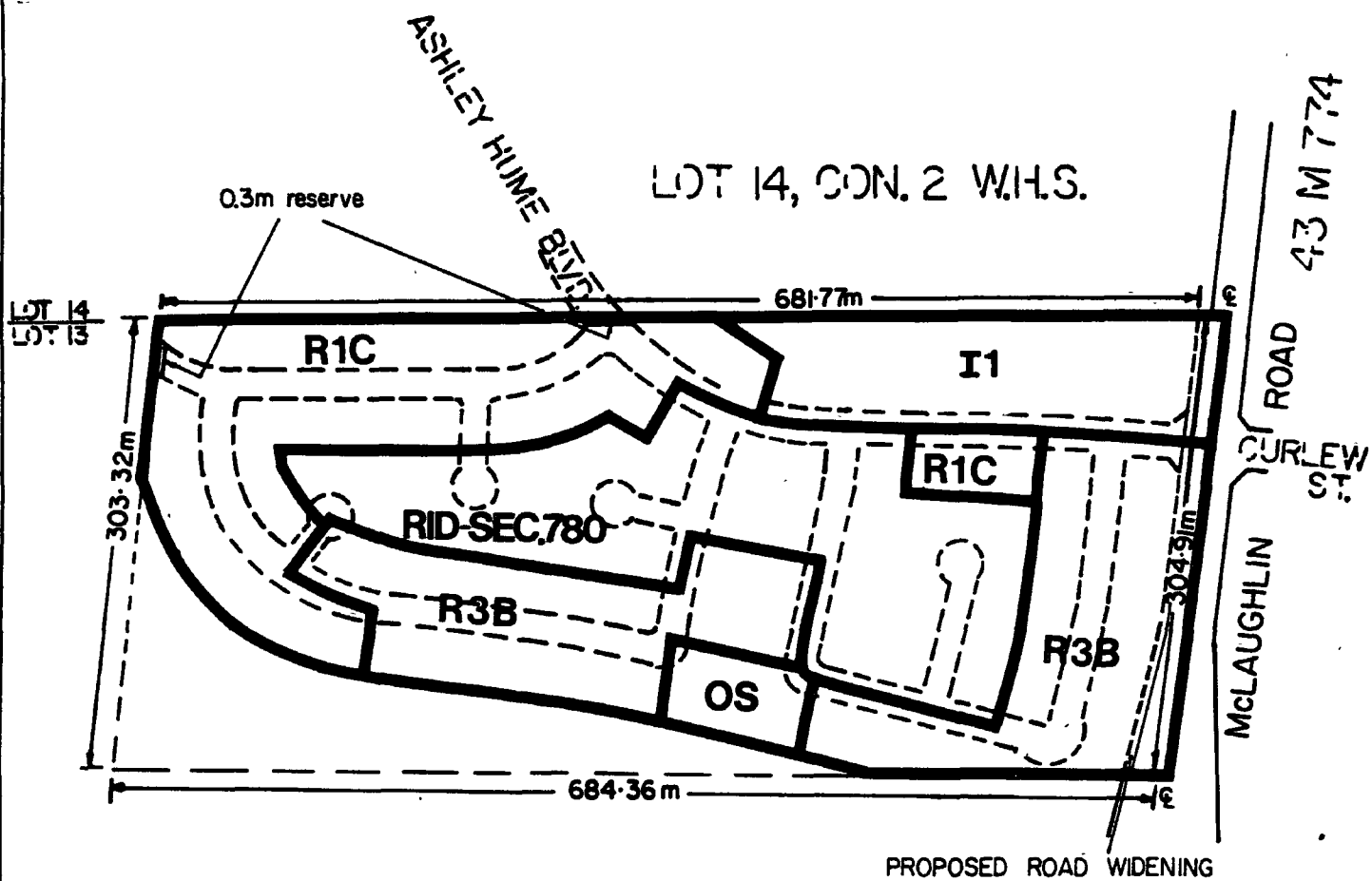


