1. By-law 93-93, as amended, is further amended as follows:

(1) by deleting from Schedule XIV the following items:


(2) by adding to Schedule XIV the following items:

| Ray Lawson Boulevard | South            | 150 metres east of Timberlane Drive and Cherrytree Drive / Malta Avenue    | Anytime   |
