BY-LAW

Number 275-88

To amend By-law 139-84 (part of Lot 15, Concession 1, W.H.S., in the geographic Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended:

(1) by changing, on Sheet 6 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE-FAMILY C ZONE (RIC) to RESIDENTIAL SINGLE-FAMILY C - SECTION 682 ZONE (RIC-SECTION 682).

(2) by adding thereto the following section:

"682. The lands designated RIC - SECTION 682 on Sheet 6 of Schedule A to this by-law:

682.1 shall only be used for the purposes permitted by section 12.3.1.

682.2 shall be subject to the following requirements and restrictions:

(a) Minimum Lot Width:

Interior Lot - 11.7 metres

Corner Lot - 13.9 metres

682.3 shall also be subject to the requirements and restrictions relating to the RIC Zone and all of the general provisions of this by-law which are not in conflict with the ones set out in section 682.2."

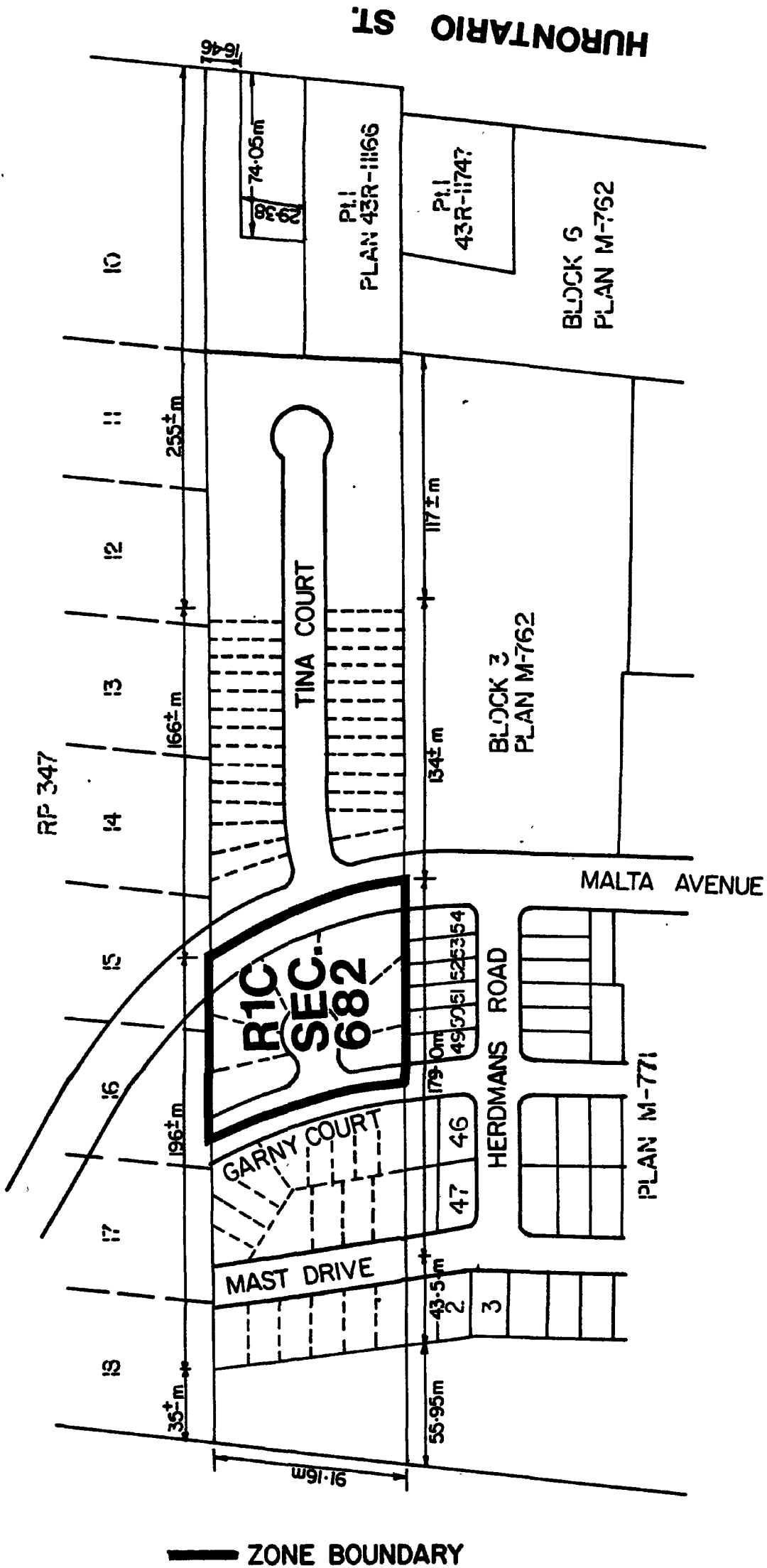

— ZONE BOUNDARY

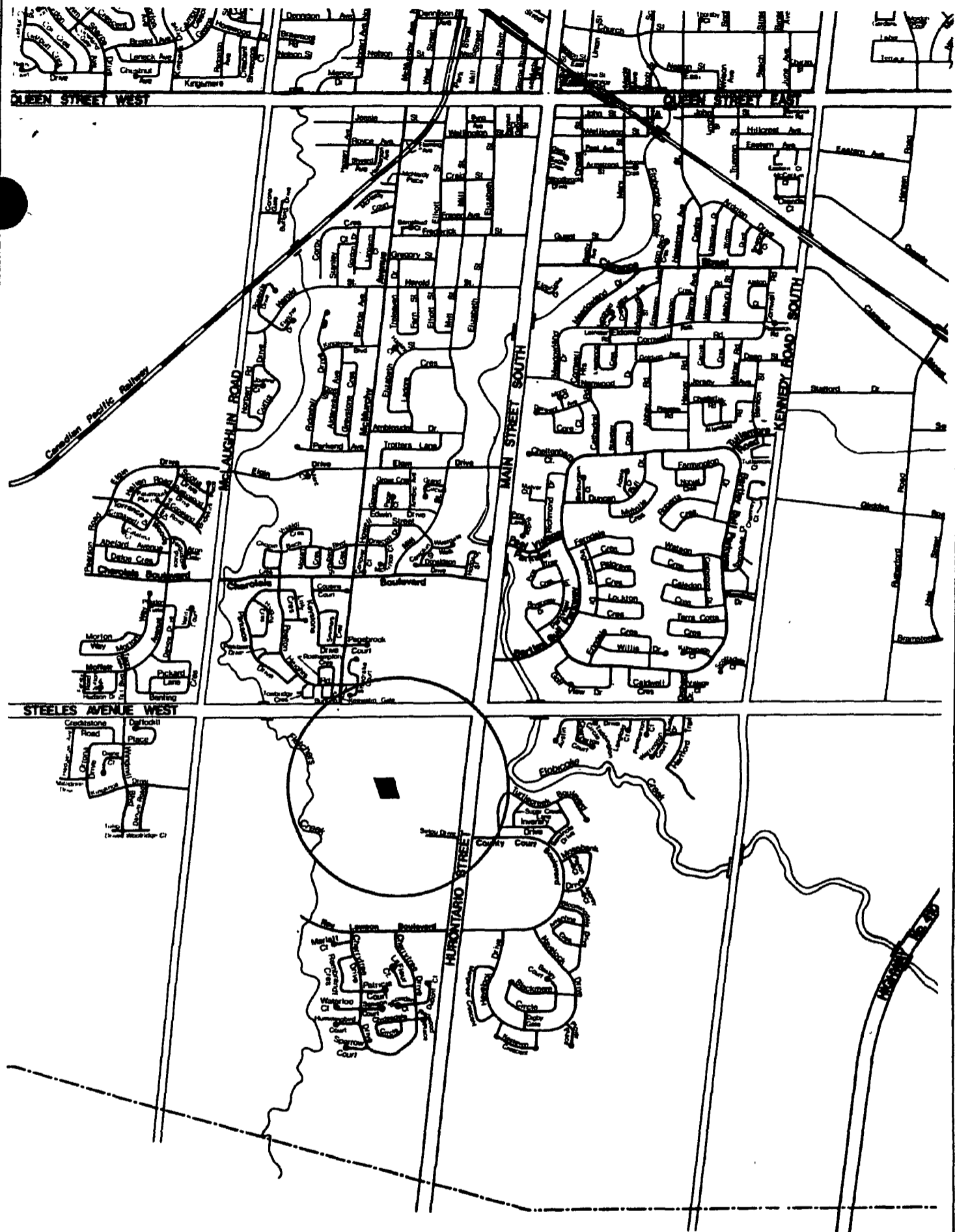
PART LOT 15, CON. 1, W.H.S. (TOR.)



DECLARATION


I, LEONARD J. MIKULICH, of the City of Brampton, in
