An Interim Control By-Law Applicable to Part of the Area Subject to By-Law 200-82, as Amended, and Zoning By-Law 2004.

The Council of the Corporation of the City of Brampton ENACTS as follows:

The lands described as part of Lots 5 and 6, Concession 1 W.H.S. and part of Lots 5 and 6, Concession 1 E.H.S. as outlined on Schedule A to this bylaw shall not have any buildings or structures erected thereon for any of the uses set out below, nor shall the land be used for any of the uses set out below, except for those uses that were in existence on the date of the enactment of this by-law.

- a grocery store or supermarket; a)
- a motor vehicle or boat sales, rental leasing or service b) establishment, a motor vehicle repair shop, and a motor vehicle or boat parts and accessories sales establishment;
- a motor vehicle body shop; c)
- a motor vehicle washing establishment; d)
- a automobile service station; e)
- a parking lot; f)
- a personal service shop; g)
- a convenience restaurant; h)
- a bank less than 10,000 square feet; i)
- a service station or gas bar; j)
- a taxi or bus station; and, k)
- a produce outlet. 1)
