# BY-LAW

Number 275-2007

To approve the expropriation of certain lands  
for the purpose of a road widening (Kennedy Road)

**WHEREAS** the Council of The Corporation of the City of Brampton, at its meeting of February 28, 2007, enacted by-law 65-2007 to authorize the expropriation of certain lands and interest in land for the purpose of widening Kennedy Road South;

**AND WHEREAS** notice of Council's intention to expropriate the said lands was served on all persons with an interest in the lands in accordance with the provisions of the Expropriations Act, R.S.O. 1990, c.E26, as amended;

**AND WHEREAS** none of the persons with an interest in the lands requested a Hearing of Necessity under the provisions of the Expropriations Act;


**NOW THEREFORE** the Council of The Corporation of the City of Brampton  
**ENACTS AS FOLLOWS:**

1. The expropriation of the lands in the City of Brampton described in Schedule "A" to this by-law for the purposes of a road widening of Kennedy Road South is hereby approved.
2. The Mayor and City Clerk are hereby authorized to execute on behalf of The Corporation of the City of Brampton as approving authority, all notices, plans and other documents required by the Expropriations Act, R.S.O. 1990, c.E26, as amended, in a form approved by the City Solicitor, in order to complete the expropriation of the said lands.
