# BY-LAW

Number 276-2008

To amend Traffic By-law 93-93  
by amending the schedules relating to FIRE ROUTES, RATE OF SPEED,  
THROUGH HIGHWAYS, STOP SIGNS

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by adding to Schedule XXII the following items:
