A By-law to amend By-law Number 45-74, as amended, for the regulation of traffic

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to further amend By-law Number 45-74, being a By-law for the regulation of traffic.

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby ENACTS as follows:

1) That Schedule "A" to By-law Number 45-74, as amended, be further amended by the deletion therefrom of the following, under the appropriate columns thereof:
