To amend By-law 285-85 and
Resolution C067-98-F8 (Retirement
Allowances and RRSP Contributions
for members of Council)

WHEREAS By-law 285-85 as amended by By-law 200-90 provided for the payment of a retirement allowance to members of City Council;

AND WHEREAS Resolution C067-98-F8 provided for the payment of contributions to an RRSP program for members of City Council;

AND WHEREAS on the 8th day of November, 1999 City Council decided that the rates of payment for and contributions to the retirement allowance and RRSP program respectively be amended and this decision should have been implemented at that time by amending By-law 285-85 and Resolution C067-98-F8;

AND WHEREAS payments and contributions have been made at these amended rates to members of City Council and members of City Council who retired after the 8th day of November, 1999;

AND WHEREAS the purpose of this by-law is to adopt, ratify and confirm these amended rates and all payments and contributions made to members of City Council and members of City Council who retired after the 8th day of November, 1999 at these amended rates;

NOW THEREFORE the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**

1. By-law 285-85 as amended by By-law 200-90 is further amended by:

(1) substituting the words "Commissioner of Finance and Treasurer" for the words "Chief Administrative Officer and Treasurer" in subsection (1) of section 2; and

(2) repealing subsection (2) of section 2 and substituting therefor the following subsection (2);

"The retirement allowance for a member of the Council shall be calculated at the rate of one month's current salary for every year of

continuous service to a maximum of twelve (12) months and that no such allowance shall be payable in the case of a member who is deprived of the office pursuant to or as a direct result of a judicial determination."

2. The rate of contribution to the RRSP program for members of City Council established by Resolution C067-98-F8 shall be at the rate of six percent (6%) based on full salary, two-thirds (2/3) car allowance and the taxable benefit applied to the Group Life Insurance.
3. This by-law shall come into force and effect on and from the 8th day of November, 1999 and all payments of retirement allowances and RRSP contributions made at the rates established by this by-law to members of Council and members of Council who retired after the 8th day of November, 1999 are ratified and confirmed.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 30th day of September, 2002.
