# BY-LAW

Number 282-2010

To amend Traffic By-law 93-93  
by amending the Schedules relating to NO STOPPING (Schedule XV), PARKING METERS (ON-STREET) (Schedule XX) and THROUGH HIGHWAYS (Schedule III)

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 as amended, is hereby further amended as follows:

(1) by removing from Schedule XV thereto the following item:

## NO STOPPING

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
John Street	South	Main Street South and Chapel Street	Anytime

(2) by adding to Schedule XX thereto the following item:

## PARKING METERS (ON-STREET)

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 FEES	COLUMN 5 MAXIMUM TIME PERMITTED	COLUMN 6 TIMES OR DAYS
John Street	South	A point 17 metres east of Main Street South and a point 13 metres west of Chapel Street	10 min for each 25 cent piece 40 min for each 1 dollar piece	90 minutes	9:00 am – 6:00 pm Monday - Saturday

(3) by removing from Schedule III thereto the following items:

Bloomsbury Avenue	The north limit of Parliament Hill Place/Van Hoof Crescent and the south limit of the roadway
Thorndale Road	The north limit of Ebenezer Road and the north limit of Tyler Avenue

Thorndale Road	The north limit of Amethyst Circle/Peridot Road and the north limit of Cottrelle Boulevard
Thorndale Road	The south limit of Cottrelle Boulevard and the south limit of Shadyridge Road
Thorndale Road	The north limit of Eastbrook Way and the north limit of Amethyst Circle/Peridot Road



Agincourt Circle	The north limit of the intersection of Agincourt Circle with itself and the west limit of Royalwest Drive
Annual Circle	The north limit of the intersection of Annual Circle with itself and the west limit of Royalwest Drive
Attmar Drive	The south limit of Ebenezer Road and the east limit of the roadway
Beachville Circle	The west limit of Royalwest Drive and the south limit of the intersection of Beachville Circle with itself
Beacon Hill Drive	The north limit of Adamsville Road and the east limit of Mississauga Road
Bliss Street	The east limit of Literacy Drive and the west limit of Gardenbrooke Trail
Bloom Drive	The south limit of Castlemore Road and the north limit of Academy Drive
Bloomsbury Avenue	The north limit of the roadway and the north limit of Richgrove Drive
Bloomsbury Avenue	The south limit of Richgrove Drive and the north limit of Latania Boulevard
Bloomsbury Avenue	The south limit of Latania Boulevard and the south limit of the roadway
Castle Oaks Crossing	The east limit of The Gore Road and the west limit of Gardenbrooke Trail
Castle Oaks Crossing	The east limit of Gardenbrooke Trail and the east limit of the roadway
Clarkway Drive	The south limit of Mayfield Road and the north limit of Countryside Drive
Clarkway Drive	The south limit of Countryside Drive and the north limit of Cottrelle Boulevard
Clearfield Drive	The north limit of the roadway and the north limit of Clarkway Drive
Currant Road	The south limit of Sleightholme Crescent and the north limit of Newington Crescent
Gardenbrooke Trail	The east limit of The Gore Road and the south limit of Castlemore Road
Garryoaks Drive	The east limit of McVean Drive and the west limit of Midsummer Drive
High Meadows Road	The north limit of the roadway and the north limit of Snapdragon Square
Literacy Drive	The south limit of Sleightholme Crescent and the north limit of Castle Oaks Crossing
Midsummer Drive	The east limit of the intersection of Midsummer Drive with itself and the north limit of Cottrelle Boulevard
Mission Ridge Trail	The south limit of Castle Oaks Crossing and the west limit of Thorndale Road
Mulgrave Street	The east limit of Thorndale Road and the west limit of Gardenbrooke Trail
Newington Crescent	The south limit of Sleightholme Crescent and the west limit of Literacy Drive


Pomell Trail	The east limit of Clearfield Drive and the north limit of the roadway
Royalwest Drive	The south limit of Williams Parkway and the north limit of Queen Street
Sleightholme Crescent	The west limit of Bloom Drive (northern intersection) and the west limit of Bloom Drive (southern intersection)
Snapdragon Square	The west limit of the intersection of Snapdragon Square with itself and the east limit of the intersection of Snapdragon Square with itself
Thorndale Road	The south limit of Castle Oaks Crossing and the north limit of Gardenbrooke Trail
Thorndale Road	The north limit of Amethyst Circle/Peridot Road and the north limit of Eastbrook Way
Thorndale Road	The south limit of Eastbrook Way and the south limit of Shadyridge Road
Thorndale Road	The north limit of Tyler Avenue and the north limit of Ebenezer Road
Toddville Road	The east limit of Thorndale Road and the west limit of Gardenbrooke Trail
Versailles Crescent	The east limit of Clarkway Drive (southern intersection) and the east limit of Clarkway Drive (northern intersection)
