**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to THROUGH HIGHWAYS (Schedule III),
STOP SIGNS (Schedule IV) and FIRE ROUTES (Schedule XXII)**

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Tilsonburg Avenue	The east limit of Fiancial Drive and the east limit of the roadway
Veterans Drive	The north limit of the roadway and Creditview Road
Humberwest Parkway	The east limit of Airport Road and the south limit of Fairlawn Boulevard

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:

Sussexvale Drive	The north limit of Templehill Road and the west limit of Egerton Street
Delambray Street	The south limit of Sussexvale Drive and the north limit of Pentonville Road
Loftsmoor Drive	The south limit of Sussexvale Drive (northerly intersection) and the north limit of Sussexvale Drive (southerly intersection)
Pentonville Road	The east limit of Loftsmoor Drive and the west limit of Egerton Street
Gosfield Drive	The east limit of Egerton Street and the south limit of Templehill Road
Ross Drive	The south limit of Countryside Drive and the north limit of Templehill Road
Templehill Road	The east limit of Delambray Street and the west limit of Dixie Road
Berkwood Hollow	The east limit of Creditview Road and the easterly limit of the roadway
Dusk Drive	The east limit of James Potter Road and the west limit of Chinguacousy Road

Elmcrest Drive	The south limit of Bonnie Braes Drive and the north limit of Dusk Drive
Leadership Drive	The south limit of James Potter Road and the west limit of Leadership Drive itself
Kimborough Hollow	The south limit of Bonnie Braes Drive and the north limit of James Potter Road
Arrowpoint Drive	The south limit of Fallmeadow Circle and the west limit of James Potter Road
Lloyd Sanderson Drive	The west limit of George Robinson Drive and the west limit of Vernosa Drive
Tilsonburg Avenue	The east limit of Financial Drive and the east limit of the roadway
Veterans Drive	The north limit of the roadway and the west limit of Creditview Road

3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:

Humberwest Parkway and Fairlawn Boulevard/Daisyfield Boulevard	Eastbound on Humberwest Parkway
Humberwest Parkway and Fairlawn Boulevard/Daisyfield Boulevard	Southbound on Daisyfield Boulevard
Humberwest Parkway and Fairlawn Boulevard/Daisyfield Boulevard	Northbound on Fairlawn Boulevard
