Number 285-2004

A By-law to Amend By-law 191-2003
being a By-law to Appoint a Chief Building
Official and Inspectors for the Enforcement
of the Building Code Act and Regulations

WHEREAS section 3(2) of the *Building Code Act*, S.O. 1992 requires the Council of each municipality to appoint a Chief Building Official and such inspectors as are necessary for the purposes of the enforcement of the *Building Code Act*;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. Section 3 of By-law 191-2003 is hereby amended as follows:
 - (1) S. Dunford and D. Fremstad are deleted from the list.
2. N. Ahman and R. Brown are appointed as inspectors for the enforcement of the *Building Code Act* (and regulations made thereunder) in the City of Brampton.
3. Attached hereto as Schedule "A" is an up-to-date list of inspectors' names.


