Re: Lease of Lands from Marathon Realty Company Ltd. Our File: C-3/85

BACKGROUND:

The attached memorandum of agreement refers to a lease for the maintenance of a storm ditch on C.P.R. lands. This lease is reviewed every five years and the rent is adjusted.

The increase for the next five-year period is from \$2,100.00 per year to \$2,660.00 per year and would appear to be reasonable.

RECOMMENDATION:

It is recommended that the Mayor and Clerk be authorized to execute the Memorandum of Agreement with Marathon Realty Company Ltd. agreeing to an increase in rent from \$2,100.00 per year to \$2,660.00 per year for the five year period commencing December 1, 1985.




