BY-LAW

Number 291-2004

To repeal by-laws exempting lands
from part lot control

WHEREAS subsection 50(5) of the *Planning Act*, R.S.O. c. P.13 has imposed part lot control on all lands within registered plans within the City of Brampton;

AND WHEREAS, pursuant to subsection 50(7) of the *Planning Act*, the Council of a municipality may, by by-law, provide that subsection 50(5) of the *Planning Act* does not apply to land within such registered plan or plans of subdivision or parts thereof, as are designated in the by-law;

AND WHEREAS, The Corporation of the City of Brampton has passed by-laws, pursuant to subsection 50(7) of the *Planning Act* thereby exempting several properties from part lot control under subsection 50(5) of the *Planning Act*;

AND WHEREAS, it is appropriate to repeal those by-laws and restore part lot control on those properties;

AND WHEREAS, pursuant to subsection 50(7.5) of the *Planning Act*, the municipality may repeal by-laws that exempted properties from part lot control;

NOW THEREFORE, The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS**:

1. THAT the by-laws exempting properties from subsection 50(5) of the *Planning Act*, which are listed on Schedule "A" to this by-law, are hereby repealed, and part lot control shall be restored on the properties affected by these by-laws.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 13th day of September, 2004.
