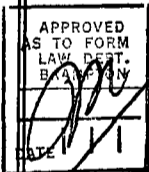
To amend By-law 139-84 (part of Lot 14, Concession 1, W.H.S., in the geographic Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended by By-law 250-87, is hereby further amended:
 - (1) by changing, on Sheet 6 of Schedule A thereto, the configuration and limits of the zoning designations for the lands shown outlined on Schedule A to this By-law, to the configuration and limits shown outlined on Schedule A hereto.
 - (2) by deleting therefrom, SCHEDULE C - SECTION 778 and 779.
 - (3) by adding thereto, as SCHEDULE C - SECTION 778 and 779, Schedule B to this By-law.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,

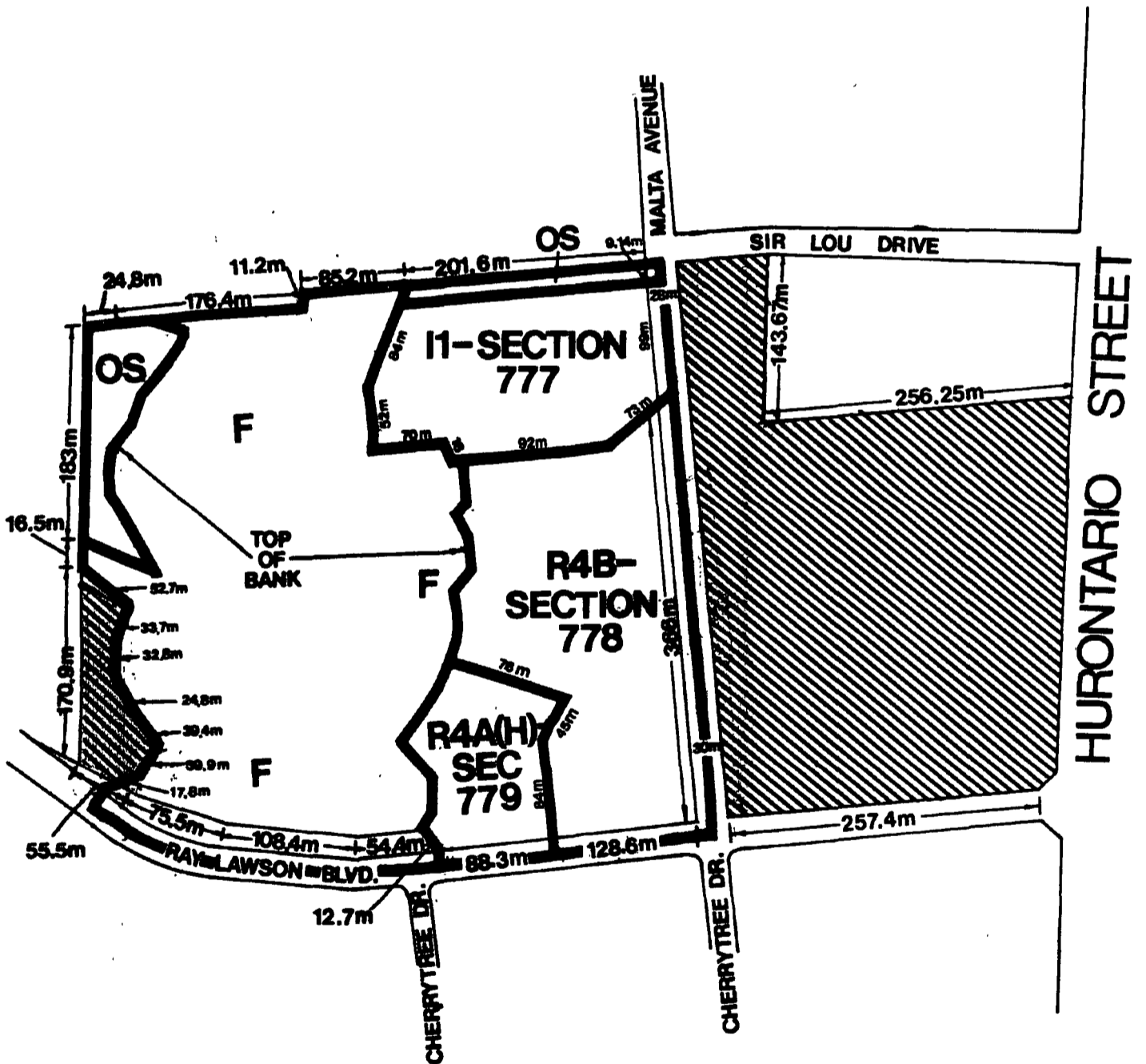

PART LOT 14, CON. I, W.H.S. (TOR.)

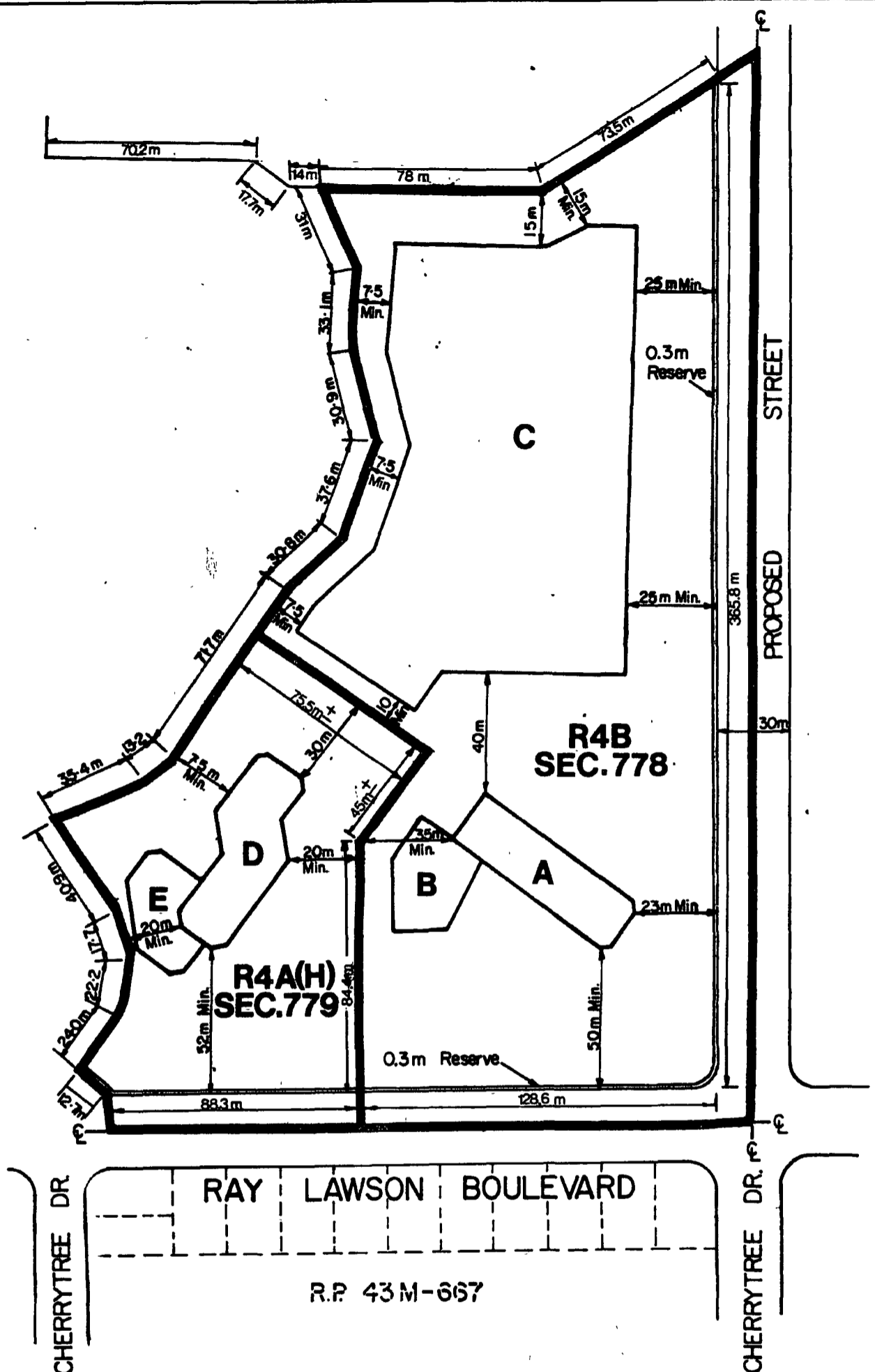




