BY-LAW

Number 298-77

A By-law to authorize a capital expenditure in the amount of \$1,710,000.00 for the construction of certain works.

WHEREAS the Council of The Corporation of the City of Brampton desires to undertake the construction of those projects set out in Schedule "A" attached hereto;
NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That the Council of The Corporation of the City of Brampton shall undertake the construction of those projects set out in Schedule "A" attached hereto at a total estimated cost of \$1,710,000.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of The Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$1,710,000.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 28th day of November, 1977.

1. <u>Reconstruction of Queen Street West from McMurchy Avenue to George Street</u>		
Installation of storm sewers, granular base road, curbs and gutters, asphalt paving, sidewalks and sodding of boulevards.	\$560,000.00	\$300,000.00
2. <u>Reconstruction of McLaughlin Road North from Queen Street to C.N.R. Bridge</u>		
Including storm sewers, excavation, granular base, curbs and gutters, asphalt pavement, sidewalks, boulevard sodding and related works	\$800,000.00	\$450,000.00
3. <u>Reconstruction of 15 Sideroad Bridge</u>		
Removal and replacement of existing deficient structure on 15 Sideroad east of 9th Line East (Gore Road) including road reinstatement and channelization	\$150,000.00	\$30,000.00
4. <u>Reconstruction of Davidson Road from Rutherford Road to 1,000 feet easterly</u>		
Including granular base, excavation, drainage culverts, asphalt pavement, boulevard sodding and related works	\$100,000.00	\$50,000.00
5. <u>Construction of Pedestrian Overpass Trueman Street</u>		
Construct pre-stressed concrete overpass for pedestrians only across main line C.N.R. at south end of Trueman Street to Sir Winston Churchill School	\$100,000.00	\$50,000.00
