# BY-LAW

**Number** 298-79

A By-law to amend By-law  
Number 33-79 being a by-law for the  
Regulation of Traffic

WHEREAS the Council of the Corporation of the City of Brampton deems it expedient and advisable to amend By-law Number 33-79, being a by-law for the regulation of traffic.

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby enacts as follows:

1. By-law Number 33-79 is hereby further amended by the deletion from Schedule XIX of the following items under the appropriate columns thereof.

Rate of Speed - 80 Kilometres/Hour

2. By-law Number 33-79 is hereby further amended by the addition to Schedule XVII of the following items under the appropriate columns thereof.

Rate of Speed - 60 Kilometres/Hour

Kennedy Road (First Line East)      Somerset Drive and a point 1570 metres south of Piedmont Drive

3. By-law Number 33-79 is hereby further amended by the addition to Schedule XVIII of the following items under the appropriate columns thereof.

Rate of Speed - 70 Kilometres/Hour

Kennedy Road (First Line East)      Fifteen Sideroad and Somerset Drive

Kennedy Road (First Line East)      A point 1570 metres south of Piedmont Dr. and the Highway #7 By-pass

Rate of Speed - 80 Kilometres/Hour


