# BY-LAW

**Number** 304-84

To amend By-law 56-83, as it pertains  
to Part of Lot 17, Concession 8,  
Northern Division

The Council of The Corporation of the City of Brampton hereby  
ENACTS as follows:

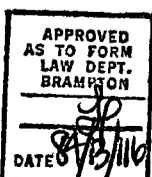
1. By-law 56-83, as amended, is hereby further amended:
  - (1) by changing the zoning classification of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL ESTATE HOLDING (REH) to RESIDENTIAL ESTATE TWO (RE2) and FLOODPLAIN (F), such lands being part of Lot 17, Concession 8, Northern Division, in the geographic Township of Toronto Gore.
  - (2) by deleting Sheet 2 of Schedule A thereto, and substituting therefor Schedule B to this by-law.

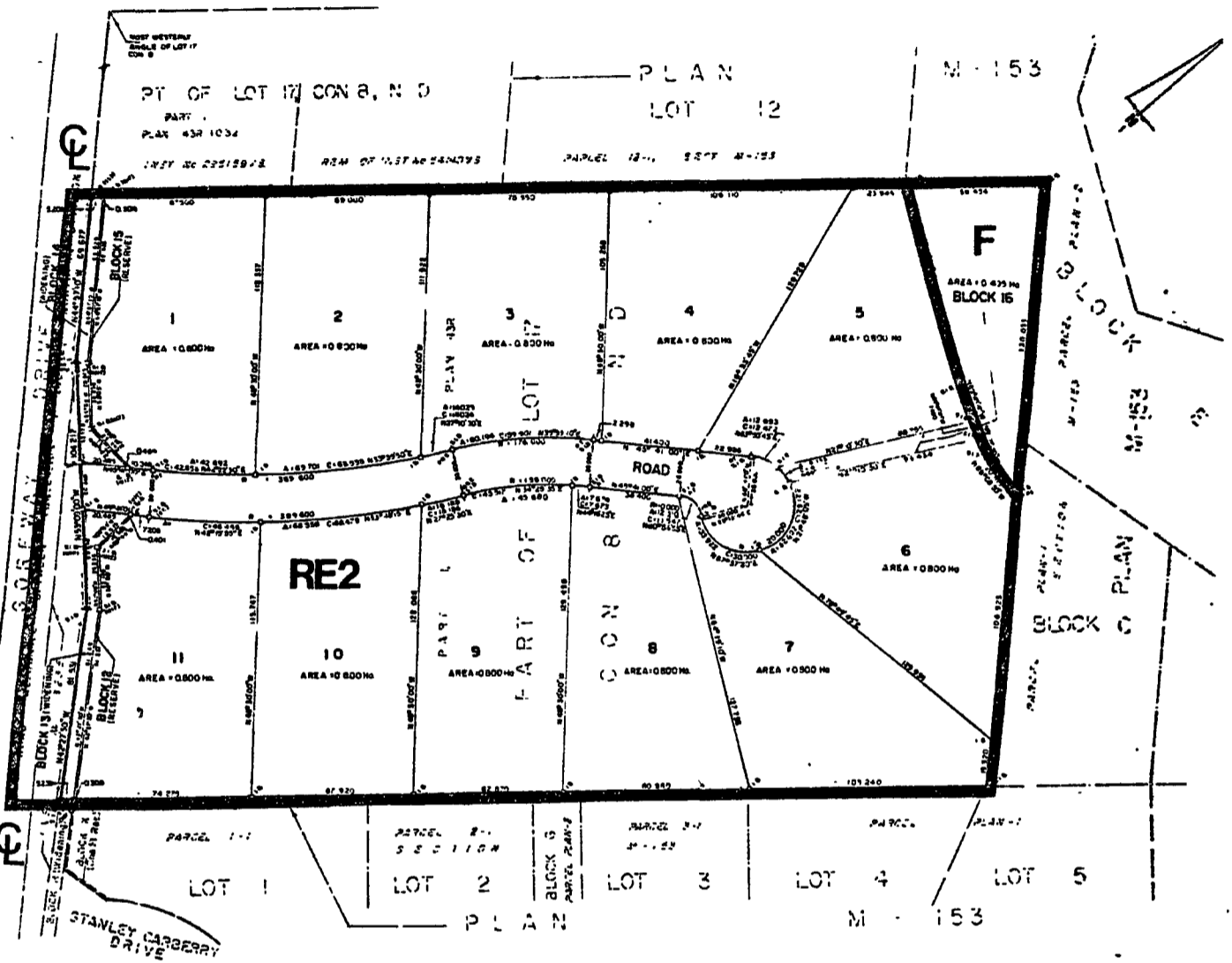
READ a FIRST, SECOND and THIRD time and PASSED IN OPEN COUNCIL.

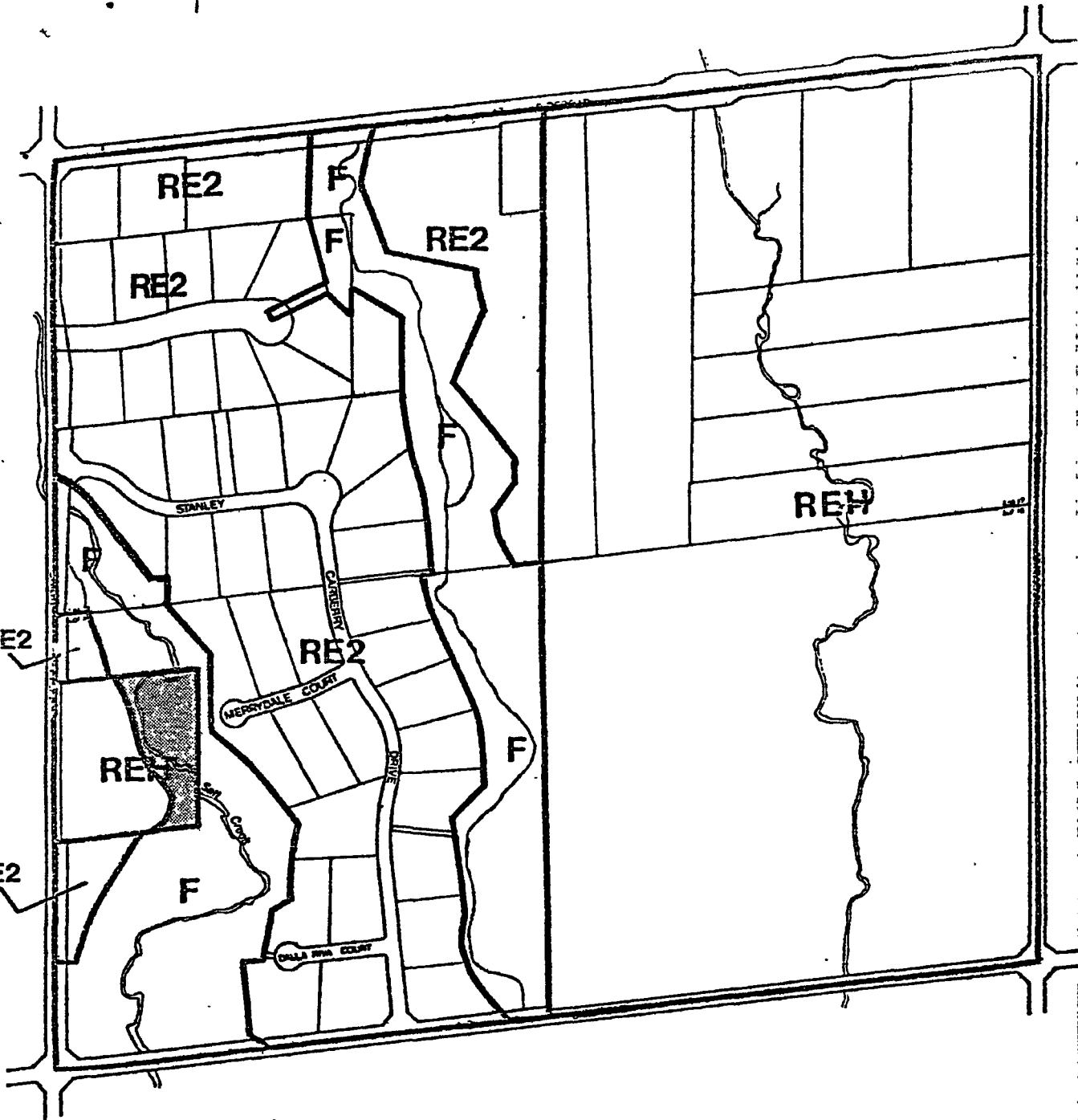

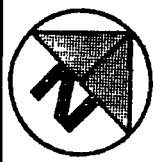
