To amend By-law 93-93,

THROUGH HIGHWAYS, STOP SIGNS

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Worthington Avenue	The south limit of Fairhill Avenue and the north limit of Regional Road 7
Fairhill Avenue	The east limit of Creditview Road and the west limit of Chinguacousy Road

(2) by adding to Schedule III thereto the following items:

THROUGH HIGHWAYS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Worthington Avenue	The south limit of Fairhill Avenue and the north limit of Springhurst Avenue/Grovedwood Drive
Worthington Avenue	The south limit of Springhurst Avenue/Grovedwood Drive and the north limit of Regional Road 7
Fairhill Avenue	The east limit of Creditview Road and the west limit of Brisdale Drive
Fairhill Avenue	The east limit of Brisdale Drive and the west limit of Chinguacousy Road

(3) by adding to Schedule IV thereto the following items:
