BY-LAW

Number 310-79

A By-law to amend By-law 5500, as amended, being the zoning by-law for that part of the former Town of Mississauga now part of the City of Brampton.

The Council of The Corporation of the City of Brampton
ENACTS as follows:


- 1) Map 45 of Schedule B attached to By-law 5500 is hereby amended by changing thereon the zoning designation of the lands shown outlined on Schedule A attached to this by-law from INDUSTRIAL ONE (M1) to INDUSTRIAL ONE-SECTION 768 (M1-SECTION 768).
- 2) By-law 5500 is hereby amended by adding thereto the following section:
"768. The land designated as M1-SECTION 768 on Schedule B hereto attached:

768.1 shall only be used for the purposes permitted by Sections 109(a), 190(b) and 110(1); and

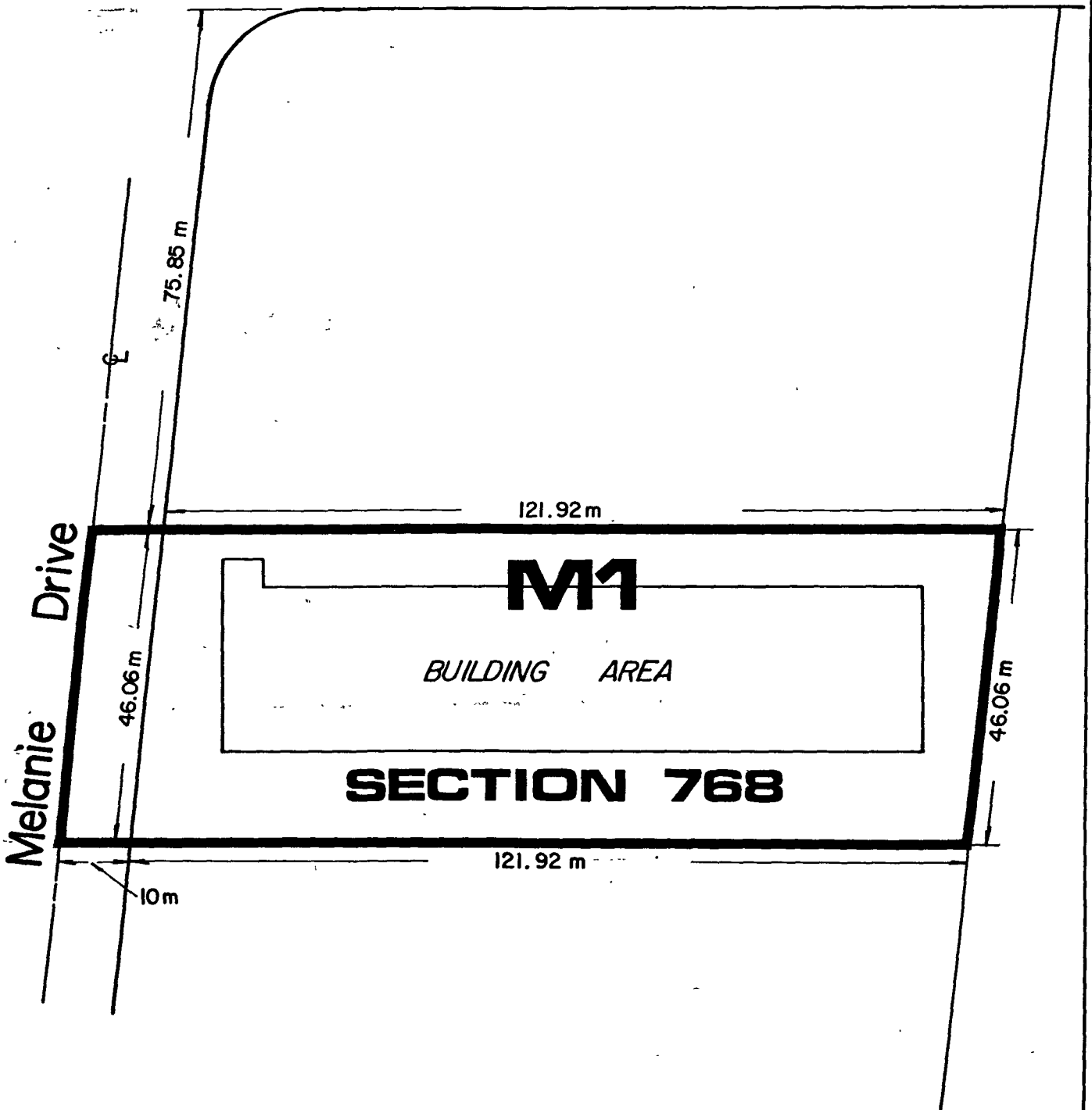
768.2 shall be subject to the requirements and restrictions relating to the M1 zone."
- 3) This by-law shall not come into force without the approval of the Ontario Municipal Board.

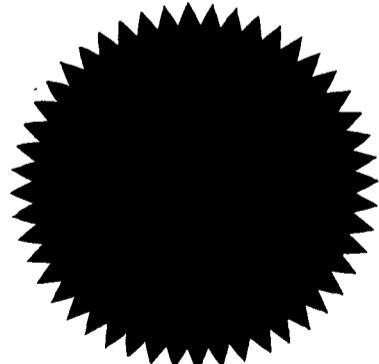
