

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

To amend By-law 17-75

(Licensing by-law)

The Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. By-law 17-75, as amended, is hereby further amended
 - (1) by inserting, as the first words after the enacting clause, the following heading:

"PART I - DEFINITIONS",

(2) by deleting the words, "For the purpose of this By-law:" from the first page thereof, and substituting therefor the following:

"1. For the purposes of this by-law,"

- (3) by placing parentheses around each of the numbers, from 1. to 21. (both inclusive), used to number the definitions, on the first, second and third pages thereof,
 - (4) by deleting the heading, "<u>II LICENSES</u>", from the third page thereof, and substituting therefor the following:

"PART II - LICENCES",

- (5) by deleting the number and words, "(2) There shall be taken out by:" on the third page thereof, and substituting therefor the following:
 - "1. A licence under this by-law, authorizing them to carry on their several trades, callings, businesses and occupations within the City of Brampton, is required and shall be taken out by:
- (6) by placing parentheses around each of the numbers, from 13. to 26. (both inclusive), used to list the different trades, callings, businesses and occupations, on the fourth and fifth pages thereof,
- (7) by deleting the words, "PROCEDURAL AND GENERAL PROVISIONS" on the sixth page thereof, and substituting therefor the following:

"PART III - PROCEDURAL AND GENERAL PROVISIONS"

(8) by deleting section 1 of <u>PART III - PROCEDURAL AND GENERAL</u> <u>PROVISIONS</u> on the sixth page thereof and substituting therefor the following:

- "1. (1) There shall be taken out by every person set out in section 1 of PART II - LICENCES of this by-law a licence under this by-law, authorizing them respectively to carry on their several trades, callings, businesses and occupations in the City of Brampton, for which licence the person obtaining the same shall pay to the City, at the time of taking out such licence, the fee fixed for that licence by Schedule A to this by-law.
 - (2) No person shall, within the limits of the City of Brampton, carry on or engage in any of the trades, callings, businesses or occupations set out in section 1 of <u>PART II - LICENCES</u> of this by-law without first having obtained a licence to do so."
- (9) by deleting section 17 thereof, and
- (10) by inserting, at the top of the tenth page thereof, which is titled, "RELATING TO ANNUAL FEES FOR LICENSES", the following words:

"Schedule A to By-law 17-75"

READ a FIRST, SECOND and THIRD TIME and PASSED in OPEN COUNCIL this 14th day of December , 1981.
