To authorize the expropriation of certain lands for the purpose of road widening

Section 6 of the <u>Municipal Act 2001</u> authorizes the Council of every corporation to pass a by-law for acquiring or expropriating any land required for the purposes of the corporation. The Council of The Corporation of the City of Brampton has determined that it is necessary and in the interest of The Corporation of the City of Brampton to acquire the lands herein described for road widening purposes.

**NOW THEREFORE** The Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:** 

- 1. The expropriation of the lands in the City of Brampton described in Schedule A, hereto attached, for the purposes of road widening, is hereby authorized.
- 2. The City Clerk is hereby authorized to execute on behalf of The Corporation of the City of Brampton as expropriating authority, all notices, applications, advertisements and other documents required by the *Expropriations Act*, R.S.O 1990, c.E.26, as amended, in order to effect the expropriation of the said lands.

**READ** a **FIRST, SECOND** and **THIRD TIME** and **PASSED** in Open Council this 15<sup>th</sup> day of October, 2003.
