 - (1) By including on Schedule A the lands shown on Schedule A to this by-law as additional lands to which Section 1994 shall apply.



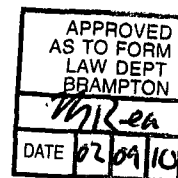

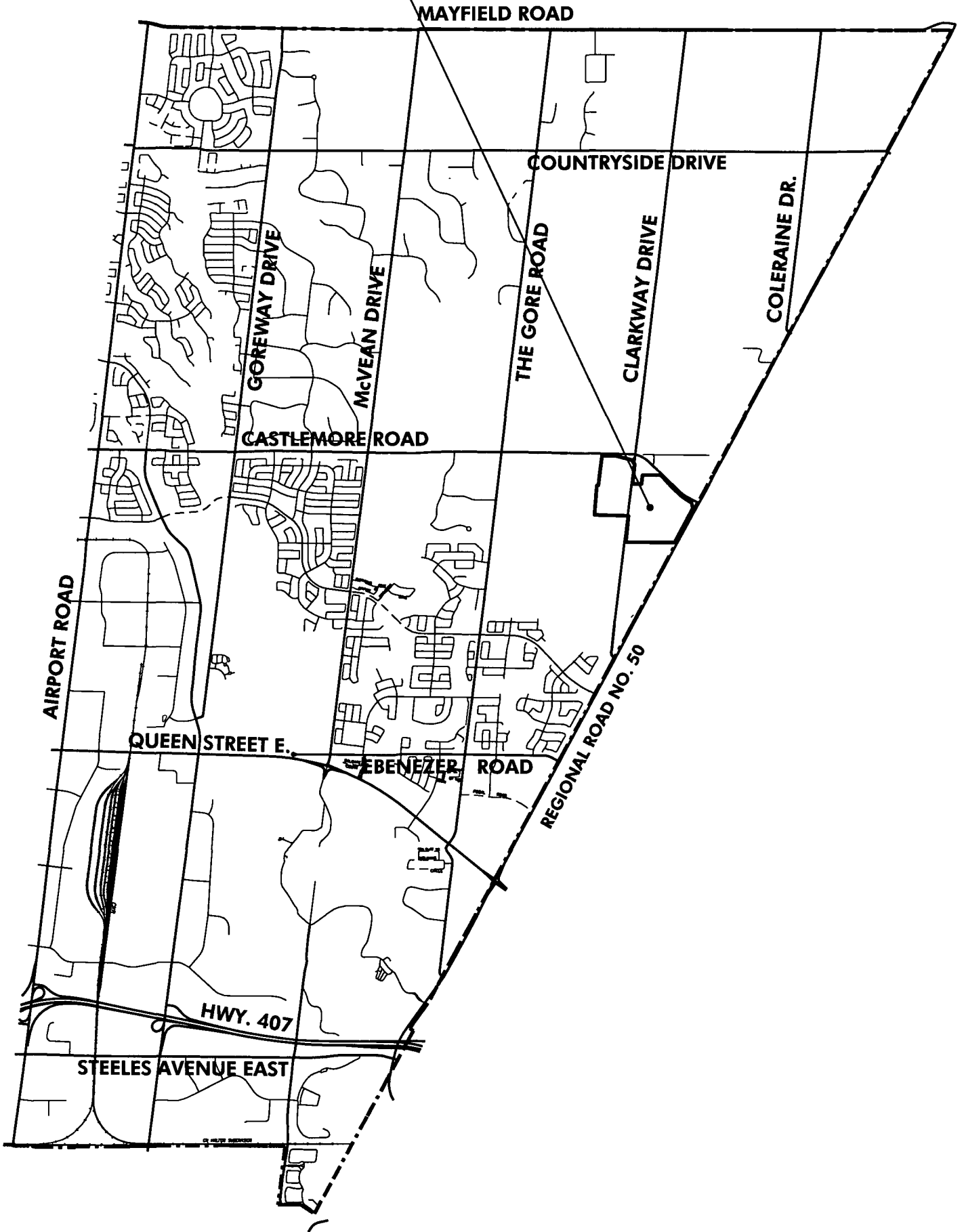
