
DECLARATION

1. By-law 270-2004, as amended, is hereby further amended:


(1) by changing Schedule A thereto, the zoning designation of the lands as shown outlined on Schedule A to this by-law:

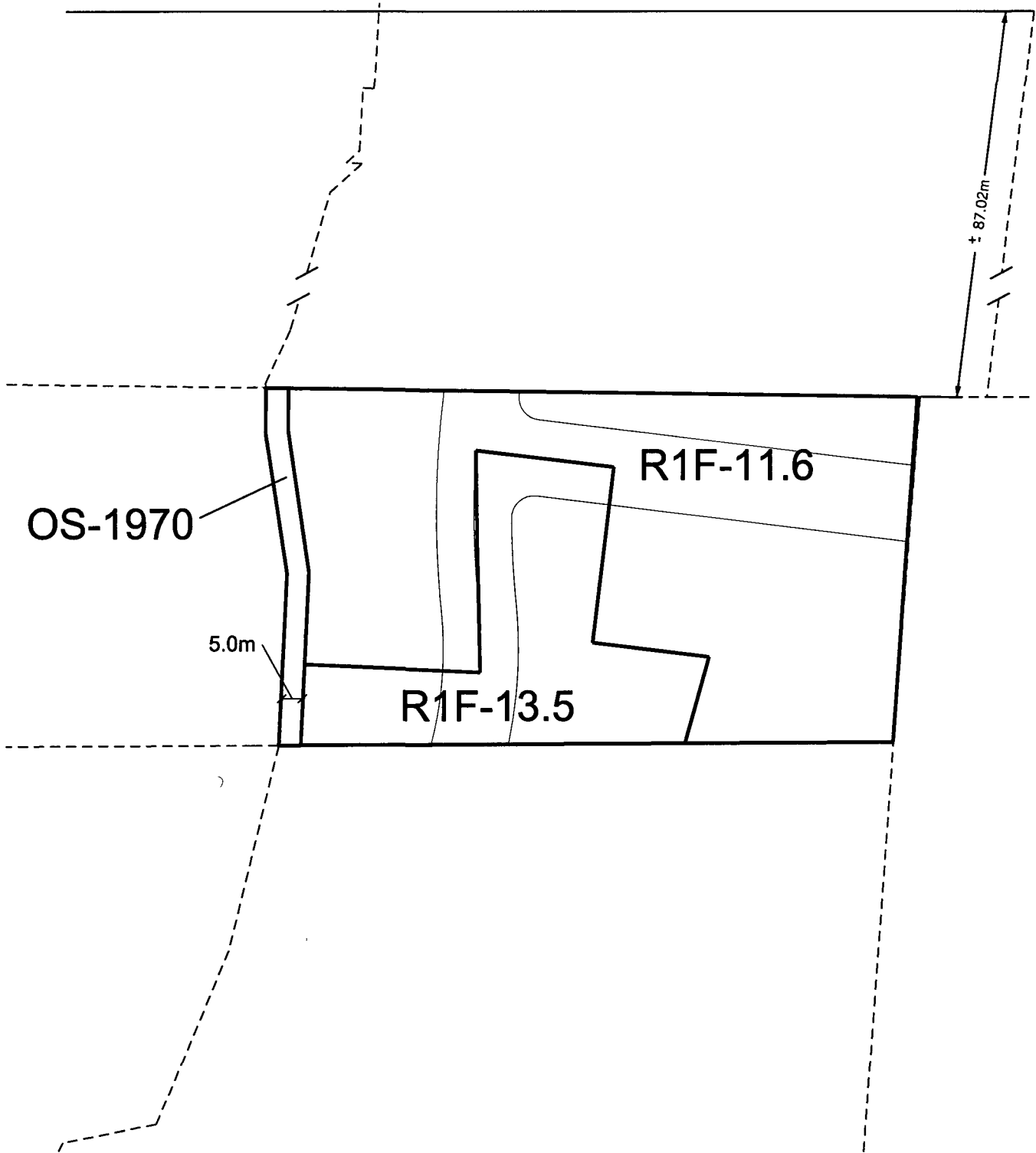
