**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to THROUGH HIGHWAYS (Schedule III),
FIRE ROUTES (Schedule XXII), NO PARKING (Schedule XIV) and STOP
SIGNS (Schedule IV)**

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items to Schedule III:

Commuter Drive	The west limit of Bleasdale Avenue and the west limit of Creditview Road
Springhurst Avenue	The east limit of Creditview Road and the west limit of Worthington Avenue
Donomore Drive	The east limit of Bleasdale Avenue and the west limit of Creditview Road
Fairhill Avenue	The east limit of Creditview Road and the east limit of Chestermere Crescent




FIRE ROUTES
